## Re: Freedom of Information Act Request (OIG Tracking Number 20-002)

This letter is in reference to your online Freedom of Information Act (FOIA) request dated October 16, 2019, to the General Services Administration (GSA), Office of Inspector General, for:

"A copy of each Administrative Subpoena issued by the GSA's Office of Inspector General during the time period January 1, 2017 to present. You may limit this request to subpoenas in cases that are closed."

Upon review of the responsive material we are releasing, I determined you are entitled to portions of the requested material under the FOIA. The bases for any redacted or withheld information are Exemptions 6, 7(C), and 7(F) of the FOIA.

Exemption 6, 5 U.S.C. §552(b)(6), **requires** withholding of information that, if released, would constitute a clearly unwarranted invasion of personal privacy. Similarly, Exemption 7(C), 5 U.S.C. §552(b)(7)(C), **requires** withholding of records or information compiled for law enforcement purposes, where disclosure could reasonably be expected to constitute an unwarranted invasion of personal privacy.

Exemption 7(F) of the FOIA, 5 U.S.C. §552 (b)(7)(F), permits the withholding of information that could endanger the life or safety of any person.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirement of the FOIA. See 5 U.S.C. §552(c) (2006 & Supp. IV (2010)). This response is limited to those records that are subject to the requirement of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not exist.

You have the right to file an administrative appeal within 120 days of the date of this letter. By filing an appeal, you preserve your rights under FOIA and give the agency a chance to review and reconsider your request and the agency's decision. The appeal must be in writing, include the GSA OIG FOIA Case Number (20-002), and contain a statement of reasons for the appeal. In addition, please enclose copies of the initial request and responsive document. The envelope and letter should be clearly marked as a "Freedom of Information Act Appeal" and addressed as follows:
