This responds to your Freedom of Information Act (FOIA) request date October 31, 2016, to the United States Office of Personnel Management (OPM). Your request seeks “Copy of any OPM FOIA Office status reports, from January 2015 to the present.” On February 7, 2020, the FOIA Manager contacted you about narrowing the scope and getting clarification of the request. You and the FOIA manager agreed on a copy of the 2015-2016 FOIA log as well as any narrative status updates.

Enclosed is a redacted copy of the OPM FOIA requests received from 2015 to 2016. Portions of the document have been redacted and are being withheld from disclosure under exemption 6 of the FOIA. Exemption 6 of the FOIA protects information that pertains to an individual “the disclosure of which would constitute a clearly unwarranted invasion of personal privacy.” 5 U.S.C. 552(b)(6). When applying exemption 6, OPM weighs the privacy interest of an individual against any public interest in the records.

The undersigned is responsible for this determination. You have the right to appeal this determination. Should you wish to do so, pursuant to 5 CFR 294.110, you must send a copy of your initial request, a copy of the letter denying the request, and a statement as to why you believe the denying official erred within 90 days from the date of this letter to:
