This is a final response letter to your FOIA request dated December 17, 2018, to the Department of Agriculture (USDA) Farm Production and Conservation Business Center (FPAC-BC). Your request was received in this office on December 26, 2018, and you requested the following:

I request a digital/electronic copy of the NRCS database of Archeological Surveys/Reviews and Cultural Resources Surveys/Reviews.

If there is a national-level dataset, I'd prefer that. But if as you indicate there is no national data, only state by state data, i will instead limit the request to three states: Maryland, Virginia, and Minnesota, for whatever timeframe is in each respective database. I presume that this narrowed request would be less burdensome.
