This is in response to your Freedom of Information Act (FOIA) request, dated October 5, 2018, for "a copy of the meeting minutes of the CIGIE Integrity Committee occurring during the timeframe January 1, 2013 to December 31, 2017. Your request was assigned FOIA case number 6330-2019-02.

We have partially completed our records search and have identified records that may be responsive to your request. Specifically, we are enclosing a copy of the Integrity Committee meeting minutes from January 26, 2016 to December 31, 2017. The records responsive to your request are contained in a Privacy Act system of records that is exempt from the access provision pursuant to 5 U.S.C. 552a (j)(2), (k)(2). However, the Privacy Act does not prohibit the release of records that are required to be disclosed pursuant to the FOIA. You are being provided access to that information which is required to be disclosed to you by the FOIA. The redacted information is subject to FOIA exemptions, as discussed below.

Exemption (b)(6) of the FOIA authorizes the withholding of information about individuals in personnel and medical files and similar files when the disclosure of such information would constitute a clearly unwarranted invasion of personal privacy.

Exemption (b)(7)(C) of the FOIA authorizes the withholding of names and details of personal information related to various individuals which, if disclosed to the public, could reasonably be expected to constitute an unwarranted invasion of personal privacy.

We are continuing to search for records that are responsive to your remaining requests.
