## SENT VIA E-MAIL

This is in response to your Freedom of Information Act (FOIA) request, dated and received on June 9, 2020, seeking access to records maintained by the Treasury Inspector General for Tax Administration (TIGTA).

Specifically, you requested:

A copy of the complete list of investigation categories used in the TIGTA investigations database, NOT a statistical report. Categories only, not the number of investigations.

On June 19, 2020, in a conversation with David Greek of this Office, you clarified that you would accept a list containing both active and inactive investigation categories.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. 552(c). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

The list of investigation categories consists of four pages. We are releasing the four pages to you in full. A copy is enclosed.

The cost incurred to process your FOIA request was less than \$25.00, the threshold set by Treasury's FOIA regulation, so no fees were assessed.
