The U.S. Office of Government Ethics (OGE) is granting in part and denying in part your Freedom of Information Act (FOIA) request, which the OGE FOIA Office received on July 9, 2020. In your request, you asked for "a copy of emails at OGE regarding or discussing the delays in submission and completion of the President's Annual Financial Disclosure this summer. I agree to limit this request to records between July 1, 2020 and July 8, 2020. I agree to limit this request to the individuals and offices which are most likely to be involved in this matter."

In response, we are enclosing 28 pages of responsive records, subject to deletions made in accordance with FOIA Exemption 5, 5 U.S.C. § 552(b)(5), as inter- and intra-agency pre-decisional deliberative process material; and FOIA Exemption 6, 5 U.S.C. § 552(b)(6), as information the disclosure of which would constitute a clearly unwarranted invasion of personal privacy. The deletions are each marked with a reference "(b)(5)," or "(b)(6)" in the enclosed copies.
