This is in response to your email (Enclosure 1) dated 26 December 2020 and received in the Information Management Office of the Office of the Director of National Intelligence (ODNI) on 28 December 2020. Pursuant to the Freedom of Information Act (FOIA) you requested "a copy of the list of the Office of the Inspector General for the Intelligence Community investigations CLOSED during Calendar Year 2020."

A search has been conducted and a record responsive to your request was located (Enclosure 2). One record is being released to you in part with the following exemption:

• (b)(3), which applies to information exempt from disclosure by statute. The relevant statute in this instance is the National Security Act of 1947, as amended, 50 U.S.C. § 3033(g)(3)(A), the Inspector General shall not disclose the identity of the employee without the consent of the employee, unless the Inspector General determines that such disclosure is unavoidable during the course of the investigation or the disclosure is made to an official of the Department of Justice responsible for determining whether a prosecution should be undertaken.
