This correspondence is in response to your Freedom of Information Act (FOIA) request dated and received in the Office of the Pardon Attorney (PARDON) on December 2, 2020. Pursuant to the Freedom of Information Act, 5 U.S.C. § 552 *et seq.*, you requested “a copy of the Office of the Pardon Attorney congressional log or congressional correspondence log during January 1, 2017 to December 2, 2020.”

After carefully considering your request, I have determined that the attached 14 pages are appropriate for release in full without redactions. For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. § 552(c). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.
