

Cabinet Affairs Weekly Briefing HUD February 5, 2009

Reform Agenda

#### **NOFAs**

We are actively examining HUD's grant distribution (NOFA) process with the intent of reforming it. We are focusing on expediting grant delivery, broadening engagement with stakeholders, improving accountability and performance measures for grantees, and increasing transparency. Additional key staff members are starting on Monday and the development of the reform agenda will be a primary focus immediately.

#### TITLE I

As part of the FHA Modernization portions of the Housing enacted over the summer, Congress authorized HUD to reform Title I, which relates to manufactured housing underwriting, loan limits, and related issues. In response to concerns raised by Rep. Frank and Sen. Corker, among other members of Congress, regarding when and how HUD was going to issue guidance for the revised program, HUD expects (pending OMB approval) to inform the Hill that it will issue a mortgagee review letter, publish notice of this letter in the federal register, and solicit comments about the approach.

# **Policy Priorities**

HUD is working with the National Economic Council, the Treasury Department, and the Council of Economic Advisers on a foreclosure prevention plan structured to significantly increase the number of loan modifications made, through many possible levers. With expectations currently to finalize the package by next week, we are preparing a rollout plan that includes press outreach and constituent/stakeholder outreach.

#### Regulations

Rule on Refinement of Income and Rent Determination Requirements: HUD will proceed to extend the effective date of a final rule signed by Secretary Preston on January 13, 2009 and published on January 27, 2009. This rule responds to a longstanding Office of Inspector General audit concerning overpayment and underpayment of subsidies, but triggered substantial concerns because ambiguous language suggested that it would permit public housing authorities to evict "mixed" households (those with and without persons with proof of legal status in the U.S.). The rule provides for use of Enterprise Income Verification (EIV) designed to increase accuracy in the verification of income based on the use of Social Security numbers, but was not intended to authorize such evictions. The final rule does not take effect until March 30, 2009, but further extension of the effective date will allow time for further review of the policy in this rule

#### Major legislative activity

The Department has reviewed both the House and the American Recovery and Reinvestment Act, and has drafted technical corrections to facilitate the economic stimulus goals and achieve compliance with programmatic requirements. We hope to see those recommendations adopted in conference committee this weekend or next week

#### Press Events/Hits

First Lady Michelle Obama's visit to HUD on Wednesday, February 4, generated positive and substantive press coverage of housing elements in the economic recovery bill, and the role HUD will play in implementing those programs.

# Potential or expected press stories

The March 1, 2009 expiration of the Disaster Housing Assistance Program (DHAP) is beginning to draw press coverage. The Department is determining how best to manage the transition, and will be meeting with Senator Mary Landrieu next week to begin discussions with her on this issue. Secretary Donovan met with Secretary Napolitano on Thursday, February 5, to discuss DHAP and other post-disaster housing programs in the Gulf, and HUD will continue to work with Homeland Security to coordinate the federal government response.

#### Reports

On Friday, February 6, HUD will release the Secretary's Monthly Report on Housing and Economic Indicators for December 2008 and early January 2009. In November, housing market indicators were generally negative. Housing permits and starts, new home sales and prices, and existing house prices all declined. The most recent data on house prices based on repeat-sales indices showed declines from the previous month. Large inventories of unsold homes continue to be of concern. Mortgage interest rates decreased by 11 basis points in November to an average rate of 6.09 percent and 80 basis points in December to an average rate of 5.29.

#### Schedule

On Monday, February 9, the Secretary is attending an event hosted by the Rockefeller Foundation in honor of the New York City Acquisition Fund, which was developed by the Secretary when he was Commissioner of the NYC Department of Housing Preservation and Development and received the Innovations in American Government Award this year. The event is not open to the press.

On Friday, February 13, the Secretary will be participating in a conference hosted by New York University's Furman Center for Real Estate. He will be a keynote speaker and will outline his goals as HUD Secretary

# **Policy**

The Department plans to transition families out of the Disaster Housing Assistance Program (DHAP), which is set to end on February 28, and into the Housing Choice Voucher (HCV) program, and to allow all income-eligible families to transition into the HCV program, in contrast with the previous administration's decision to only allow senior, disabled, and extremely vulnerable families to apply. The details of the transition program are still being finalized and we hope to announce them in the next few days. HUD staff is also working on a March 5 trip to the Gulf Coast region with Secretary Napolitano, as well as a 6-month housing plan for the Gulf Coast. Secretary Donovan was interviewed this week by the New Orleans Times Picayune and the NY Times Editorial board regarding the status of DHAP and discussed, very broadly, his plans for the transition.

# Recovery

As our focus shifts to implementation of the recovery, we have established a special HUD Recovery Delivery Team, centrally coordinated through a strategic program management office within the Office of the Secretary. The Team consists of three action teams, focused on the following key areas: (1) program development and roll-out; (2) transparency and accountability; and (3) communications and public relations.

#### Foreclosure

HUD is finalizing work with the National Economic Council, the Treasury Department, and the Council of Economic Advisers on a foreclosure prevention plan structured to significantly increase the number of loan modifications made. With expectations currently to finalize the package by next week, we are working with Treasury and the White House to prepare a rollout plan that includes press outreach and constituent/stakeholder outreach. In partnership with Treasury and NEC, we have begun that constituent/stakeholder outreach this week, focusing on the broad goals of the plan and stakeholder recommendations for it.

# Reform Agenda

#### HOPE FOR HOMEOWNERS

The HOPE for Homeowners Freedom of Information Act (FOIA) Act interim rule will be published in the Federal Register in the coming week. This interim rule advises the public that the Board will provide access to records of the Board in accordance with the rules and procedures (including fee schedule) adopted by HUD under the FOIA. Because the official records of the Board will be compiled and stored at the main offices of HUD, use of HUD's FOIA regulations facilitates the administration of requests to, and responses of, the Board under the FOIA, and is similar to the FOIA procedures utilized by the Oversight Board for the Troubled Asset Relief Program.

#### TRAINING

On February 5, 190 acquisition personnel, including contract specialists, contracting officers, procurement analysts, Government Technical Representatives, Government Technical Monitors, and

Program & Project Managers attended a Procurement workshop on Fraud, Waste and Abuse presented by the Office of the Inspector General.

# Regulations

HUD published a notice on February 11, 2009, which seeks comment for a 30-day period on extending the effective date of a final rule published on January 27, 2009, as well as on the rule generally. The rule, on refinement of income and rent determination requirements, responds to a longstanding Office of Inspector General audit concerning overpayment and underpayment of subsidies, but triggered substantial concerns because ambiguous language suggested that it would permit public housing authorities to evict "mixed" households (those with and without persons with proof of legal status in the U.S.). The rule provides for use of Enterprise Income Verification (EIV) designed to increase accuracy in the verification of income based on the use of Social Security numbers, but was not intended to authorize such evictions. The final rule does not take effect until March 30, 2009. The public comment period ends on March 13, 2009, which will allow HUD further time to extend the effective date if commenters express views that such additional time would be beneficial.

#### Personnel

We continue to move forward with personnel decisions at HUD. This week, Peter Grace joined the HUD team as Special Assistant to the Secretary for Strategic Planning. Grace comes to HUD from the New York Department of Housing Preservation and Development. We are also excited about Fred Tombar joining the team as Special Assistant to the Secretary. Fred will oversee disaster issues and work with the DHAP team. The Secretary also made his final selections for the following appointments: Assistant Secretary of Housing-Federal Housing Commissioner; Assistant Secretary for Public and Indian Housing; and Assistant Secretary for Fair Housing and Equal Opportunity.

An update on appointees requiring Senate confirmation follows:

Ron Sims, Deputy Secretary of Housing and Urban Development Designee
As of today, Mr. Sims is still completing the Banking Committee's questionnaire. We are scheduled to hold the first briefing session with the HUD confirmation team and Mr. Sims on Tuesday, February 17th. In the meantime, we are working on scheduling courtesy visits with members of the Senate banking committee and other key members of Congress.

David Stevens, Assistant Secretary for Housing-Federal Housing Commissioner Designee Stevens is a 25 year housing veteran with a strong mortgage banking background. He is currently in vetting.

Sandra Henriquez, Assistant Secretary for Public and Indian Housing Designee

Ms. Henriquez currently serves as the Administrator of the Boston Housing Authority. Henriquez is an African-American woman with a strong public housing background. We are awaiting her paperwork to begin the vetting process.

Mercedes Marquez, Assistant Secretary for Community Planning and Development Designee Ms. Marquez is still undergoing the initial vet from the White House. Marquez is Latino and LGBT and is a veteran of the housing industry. She is currently in vetting.

Peter Kovar, Assistant Secretary for Congressional and Intergovernmental Relations Designee Mr. Kovar is still in vetting. This week he began meeting with potential candidates for his team. Kovar will remained employed with U.S. Rep. Barney Frank's office until his confirmation hearing is scheduled.

John Trasvina, Assistant Secretary for Fair Housing and Equal Opportunity Designee Mr. Trasvina currently serves as the President and General Counsel. He is a well known advocate and we are currently awaiting his paperwork to begin the vetting process.

Helen Kanovsky, General Counsel Designee
Ms. Kanovsky is currently in vetting. She currently serves as CEO and General Counsel for the AFL-CIO
Housing Trust.

American Recovery and Reinvestment Act

The American Recovery and Reinvestment invests \$13.6 billion in a range of HUD housing and community development activities. We expect to make initial announcements next week for over half of those funds. These award announcements will be quickly followed by the obligation of funds, in some cases within 30 days of the date of enactment.

The funds we expect to distribute next week are as follows:

- \$3 billion in public housing capital funds (by formula);
- \$2.25 billion in HOME funds;
- \$2 billion in Section 8 project based rental assistance;
- \$1 billion in Community Development Block Grant funds;
- \$255 million in Native American housing block grants; and
- \$100 million in lead based paint reduction and abatement activities.

We believe that HUD's implementation will be an early sign of a "new way of doing business" in the federal government—alacrity of action coupled with unprecedented transparency and accountability.

#### DHAP

HUD has spent the week working closely with FEMA, OMB, and DPC on an IAA and other components of an implementation plan for transitional housing assistance following the expiration of DHAP-Katrina/Rita on February 28<sup>th</sup>. This transition plan will provide an additional six months of housing assistance to families affected by the hurricanes; we will also work aggressively to enroll as many eligible families as we can in the Housing Choice Voucher program.

We expect that this plan will be announced tomorrow (Friday 2/20) as part of a larger Gulf Coast agenda, including the extension of the Executive Order creating the Office of Gulf Recovery (tk exact name) and the announcement of a trip on March 5<sup>th</sup> to the region by Secretaries Napolitano and Donovan. We have also dedicated a senior staff person on the Secretary's team to these issues and are developing a plan for engagement in the Gulf Coast region on a number of outstanding Katrina/Rita issues. One component of the plan will be a day of service sometime later this year, which the Secretary would like to use to engage thousands of Americans in the rebuilding effort.

#### Foreclosure

Secretary Donovan joined President Obama in Phoenix on Wednesday to announce the Housing Affordability and Stability Plan. The Secretary participated in an on-the-record briefing on site with Secretary Geithner, spoke to the NY Times editorial board, and also did the following one on-one interviews to discuss the plan:

HUD is now engaged in implementing the counseling and FHA/loan modification elements of the housing plan.

#### Homelessness Grants

Today, the Department announced \$1.6 billion in homeless grants on a conference call with reporters from across the country. The grants announced today are being awarded through HUD's Continuum of Care programs, and will assist approximately 6,300 local homeless assistance projects throughout the U.S., Puerto Rico and the U.S. Virgin Islands.

HUD is awarding \$24 million to create new pilot programs in 23 local communities to rapidly rehouse homeless families with children, which will be critical during these difficult economic times. These local pilot programs will become the basis of a significantly expanded \$1.5 billion federal effort, through the American Recovery and Reinvestment Act of 2009, to offer quick housing assistance to homeless families and to prevent homelessness among those facing a sudden economic crisis.

#### Schedule

- Next Monday, Secretary Donovan will join a meeting of the nation's governors at the White House, to discuss HUD implementation of the Recovery Plan and the Housing Affordability Plan.
- Next Wednesday, he will host the first of many agency-wide town halls with HUD employees, discussing HUD's role in the Recovery Plan and the Housing Affordability Plan, and the steps we will take together to build a more effective department.
- Next Friday, he will participate in a meeting of the Middle Class Task Force in Philadelphia.

# Personnel

We continue to move forward with personnel decisions at HUD. Raphael Bostic, Ph.D., Assistant Secretary for Policy Development and Research Designee Bostic is the director of the USC School of Policy, Planning and Development's master of Real Estate Development Program. Bostic joined USC's faculty after spending six years on the staff at the Federal Reserve Board of Governors. He enjoyed a successful tenure at the Fed, attaining the rank of Senior Economist. Bostic has done extensive research on consumer banking issues, with a primary focus on mortgage and small business lending, bank branching patterns, and credit scoring and automated underwriting. While at the Fed, he was responsible for studying and advising on fair lending and discrimination issues. His research on financial markets and institutions has focused on banks in community development, the role and effects of regulation in banking, housing and homeownership, urban economic growth, wage and earnings profiles, affordable housing, and policy analysis. He is currently conducting research on the ways in which the Community Reinvestment Act has influenced the behavior of lenders and credit markets.

Cabinet Affairs Weekly Briefing HUD February 26, 2009

American Recovery and Reinvestment Act

On February 25<sup>th</sup>, HUD announced the allocation of \$10.1 billion, or nearly 75 percent, of its Recovery Act funding. By February 27<sup>th</sup>, we will send signed letters from the Secretary to the Governors, Mayors, County Executives and Tribal Leaders whose jurisdictions will be receiving funds through this primarily formula-based allocation. In order to meet statutory deadlines, we will also be working with those leaders and their designees over the next 60 days (and in some cases much sooner) to execute contracts and grant agreements so that the funds can be made available for spending. HUD is also drafting its competitive Notices of Funding Availability for the remaining 25 percent of funds.

# Gulf Coast Trip

On Thursday and Friday – March 5 and 6 – Secretary Donovan will join Secretary Napolitano on a Gulf Coast tour, marking the Administration's first tour of the region, to assess the recovery and rebuilding efforts, tour disaster-affected areas, visit HUD-funded housing developments, and discuss the Administration's DHAP transition plan. The Secretary will continue. The Secretaries will hold a media availability during the tour on Thursday, and will meet with the New Orleans Times Picayune editorial board on Friday. Secretary Donovan will then head to Houston, TX on Friday to assess recovery efforts there. Separate media availabilities may be possible during that time.

# Middle Class Task Force

On Friday, February 27, Secretary Donovan will attend the first meeting of the Middle Class Task Force, on green jobs. We expect the Vice President to announce, and the Secretary to highlight, a new HUD/Department of Energy partnership to streamline and better coordinate federal weatherization efforts, and spur a new home energy efficiency industry. The Secretary will also highlight the tens of thousands of green jobs that will result from Recovery Act investments in HUD programs.

Housing Affordability Plan and Secretary Donovan's Banking Committee Testimony

Secretary Donovan testified before the Senate Banking Committee on Thursday, February 26, regarding the Administration's Housing Affordability and Stability Plan. Senators questioned the Secretary on the effectiveness of the Plan in high-cost areas, the options available for underwater borrowers, whether investors in private-label securities would participate in the plan, and the importance of outreach to increase participation. The Secretary also discussed bankruptcy reform, possibilities for how it might be structured, and the aspiration that we would reduce the need for borrowers to enter bankruptcy through the modification plan. After the testimony, the Secretary accepted Speaker Pelosi's invitation to meet with the House Democratic Caucus on Monday night about the Housing Affordability Plan. The meeting will have 100-150 attendees (caucus members and senior staff), and will be closed to the press

#### Schedule/Other Upcoming Press

Secretary Donovan will speak to the National Council of State Housing Agencies Legislative Conference on Monday March 2 where he will address the HUD's Recovery Plan implementation. Secretary

Donovan will join Secretary Geithner on Wednesday, March 4, to announce the guidelines for implementing the Homeowner Affordability Plan. The Secretaries will announce the implantation outreach, as well as consumer outreach efforts to ensure the successful execution of the Plan.

#### Personnel

Personnel decisions continue to move forward at HUD. We have a number of schedule C appointees starting work at the agency next week. We continue to work with PPO regarding PAS candidates. The majority of PAS candidates need to complete paperwork before we can move forward with the confirmation process.

# Cabinet Affairs Weekly Briefing HUD March 5, 2009

New Orleans Weekend of Service/Summer of Service Kickoff

HUD has begun internal planning for an early June weekend of service in New Orleans, which could double as the kickoff for a summer of service with a smaller number of volunteers. Goals for the weekend would include:

- Engaging tens of thousands of Americans in a New Orleans/Gulf Coast weekend of service.
- Making an immediate and substantial impact on community infrastructure in distressed Gulf Coast communities—fixing completely at least one tangible and visible problem.
- Engaging people who cannot travel to the Gulf in home-community service projects.
- Using the weekend of service as a direct recruiting opportunity for local volunteer organizations
  to acquire long-term volunteers, and as the kickoff for a summer-long service program for young
  people. This would allow for increased skilled labor and long-run projects, including tutoring,
  serving the homeless, and construction.
- Beginning to shift national social norms around service to one's community, creating community expectations for service as a part of life.

Details for the proposal have been shared with the White House. The president of a major philanthropy organization has offered to take a leave of absence to run the project.

During a separate meeting with Brad Pitt, Steve Bing, and directors of the Make it Right foundation to gather information on their housing development in New Orleans' Lower 9<sup>th</sup> Ward, Pitt and the foundation leaders expressed interest in joining with us in this service opportunity.

#### American Recovery and Reinvestment Act

HUD's American Recovery and Reinvestment Act implementation is covered in detail in our weekly report to the Vice President. We are planning for a trip to Elkhart, IN to highlight a \$3 million lead hazard grant from ARRA, and tying back to President's visit in mid-February. Elkhart County is a new awardee with no prior Lead Hazard Control funding from HUD, but the staff has strong experience in health and lead activities, and will control lead in 206 homes, reaching over 300 children. Further, the County will use a workforce investment board to recruit unemployed individuals and provide an opportunity for employment and training. Low-income individuals will be trained in lead hazard control activities.

# Upcoming Schedule

- The Secretary is tentatively planning a Los Angeles trip to highlight Neighborhood Stabilization Project investments in California, and successful HUD programs in the community.
- Next Tuesday, March 10, the Secretary will speak at the National Association of Counties Legislative Conference

# **Gulf Coast Trip**

Today and tomorrow – March 5 and 6 – Secretary Donovan is joining Secretary Napolitano on a Gulf Coast tour, marking the Administration's first tour of the region. The Secretary is today visiting the Southern University of New Orleans, the Saint Bernard Project, Abundance Square, the New Orleans DHAP Center, an East NOLA multifamilty property, and the New Orleans HUD field office. The Secretaries held a press conference today in which they announced hundreds of millions of dollars in funding to Louisiana to stimulate long-term recovery in the wake of last year's hurricane season and Hurricanes Katrina and Rita. They will meet with the New Orleans Times Picayune editorial board on Friday morning. Secretary Donovan will then head to Houston, TX on Friday to assess recovery efforts there in visits to the Houston DHAP center and Houston HUD field office. The visit to the DHAP center will be open to the press.

# Middle Class Task Force/DOE Partnership

On Friday, February 27, the Vice President announced a partnership between the HUD and the Department of Energy to coordinate home weatherization efforts under the American Recovery and Reinvestment Act, and to leverage those funds to build a home energy efficiency industry in the United States. A high-level task force composed of officials at the agencies will:

- Provide a common set of guidelines and specifications for retrofitting public housing, as well as
  privately owned, federally-subsidized rental properties;
- Coordinate the use of weatherization assistance, energy efficiency and conservation block grant and other recovery funds in local communities;
- Lead a government-wide effort to develop a common baseline for measuring home energy use and the gains from efficiency improvements; and
- Develop new home energy financing products.

The Vice President also highlighted at the meeting that HUD had allocated \$10.11 billion – three quarters of its ARRA funds – on the Wednesday prior to the meeting, a week after the President signed the bill into law.

# Housing Affordability and Stability Plan

On Wednesday, March 4, the guidelines for the Housing Affordability and Stability Plan were released, with the endorsements of Wells Fargo, Bank of America, and several other lenders. The announcement included the addition of a new program to deal with second liens, addressing a major obstacle to many homeowners receiving loan modifications to avoid foreclosure.

#### Personnel

On Wednesday, March 4th, the White House and HUD announced President Obama's intent to nominate Peter Kovar as Assistant Secretary for Congressional and Intergovernmental Relations, Peter is a 20-year veteran of Capitol Hill and currently serves as chief of staff to House Financial Services Committee Chair Barney Frank. He has made courtesy calls to Senate Banking Committee Chair Chris Dodd, Senate Banking Committee Ranking Member Richard Shelby and House Financial Services

Committee Ranking Member Spencer Bachus. He is working with HUD staff on scheduling courtesy Hill meetings with committee members the week of March 16th.

HUD Deputy Secretary nominee Ron Sims visited DC this week to receive issue briefings from key HUD policy staff and conduct courtesy Hill visits, including meeting with Senator Richard Shelby and Banking Committee staffers. On Wednesday, March 4th, Sims' official nomination papers were sent to the Clerk's office; we are awaiting notification of a confirmation hearing in the coming weeks.

# Testimony on Sustainable Communities

Next Wednesday, March 18, the Secretary will testify jointly with Secretary LaHood before the House Appropriations Subcommittee on Transportation, Housing and Urban Development, and Related Agencies. The hearing is titled: Livable Communities, Transit Oriented Development, and Incorporating Green Building Practices into Federal Housing and Transportation Policy. The Secretary will, in his testimony, identify the compelling interest for housing and transportation policy and planning to be integrated, and describe how HUD will work with DOT to integrate planning, redefine affordability to include housing and transportation costs, pursue joint research and evaluation, and engage in in-depth program review to emphasize location efficiency in all that we do.

# Middle Class Task Force/DOT Partnership

Secretary Donovan will travel to Minneapolis, MN for the March 19 Middle Class Task Force meeting on the implementation of the Recovery Act. At the meeting, he and Secretary LaHood expect to announce a high-level HUD/DOT task force to better coordinate federal transportation and housing investments and identify strategies to give American families:

- More choices for affordable housing near employment opportunities; and
- More transportation options, to lower transportation costs, shorten travel times, and improve the environment.
- Safe, livable, healthy communities.

#### The HUD/DOT task force will:

- Enhance integrated regional housing, transportation, and land use planning and investment.

  The task force will set a goal to have every major metropolitan area in the country conduct integrated housing, transportation, and land use planning and investment in the next four years.
- Redefine affordability and make it transparent. The task force will develop federal housing
  affordability measures that include housing, and transportation costs and other costs that affect
  location choices. The task force will redefine affordability to reflect those interdependent costs.
- **Develop Livability Measures.** The task force will research, evaluate and recommend measures that indicate the livability of communities, neighborhoods and metropolitan areas.
- Harmonize HUD and DOT programs. HUD and DOT will work together to identify opportunities
  to better coordinate their programs and encourage location efficiency in housing and
  transportation choices
- Undertake joint research, data collection and outreach. HUD and DOT will engage in joint research, data collection, and outreach efforts with stakeholders, to develop information platforms and analytic tools to track housing and transportation options and expenditures, establish standardized and efficient performance measures, and identify best practices.

# Upcoming Schedule

- Next Monday, March 16, the Secretary will address and speak with the National Association of Housing and Redevelopment Officials (NAHRO) Board of Governors, and speak at the NAHRO Legislative Conference. NAHRO members administer HUD programs such as Public Housing, Section 8, CDBG and HOME.
- Next Monday, March 16, the Secretary will meet with the National Association of Realtors.
- Next Tuesday, March 17, the Secretary will speak at the MacArthur Foundation Conference on Rental Preservation.
- Next Tuesday, March 17, the Secretary will address the National League of Cities.

# Iowa Recovery Funding

HUD is aware of White House interest in the lowa recovery funding, and will work with the White House to ensure that the delegations are informed of the recovery funding decisions.

# Mortgage Abuse

In light of HUD's commitment to fair lending and to address mortgage abuses, especially in light of the President's Housing Afforability and Stability Plan, Secretary Donovan will be meeting with Attorney General Holder on Tuesday to discuss how to increase fair lending and consumer protection efforts throughout the Administration. Historically, as the lead agencies on fair lending issues, DOJ and HUD have spearheaded an interagency fair lending working group which could be revitalized in light of the disproportionate concentration of subprime loans in communities of color. This initial meeting is intended to discuss this and other possible steps that might be taken.

In addition, in recognition of the rise of foreclosure rescue scams throughout the country, HUD has been in discussions with state attorneys general and state bank regulatory agencies regarding how it can most effectively contribute to addressing this issue. On a staff level, HUD has begun discussion with the Federal Trade Commission which also has regulatory authority in this area and is planning on upcoming event to announce several prosecutions of foreclosure rescue scams. It is possible that this event could showcase steps to combat mortgage abuse as an important complement to the HASP.

# New Orleans Weekend of Service/Summer of Service Kickoff

HUD is awaiting White House feedback on the proposal for an early June weekend of service in New Orleans, which could double as the kickoff for a summer of service with a smaller number of volunteers.

# Making Home Affordable

The website for the Obama Administration's housing plan, Making Home Affordable (www.makinghomeaffordable.gov), was announced on Wednesday, March 18 and debuted early Thursday morning. The President highlighted the website in his California town hall remarks.

# FY2010 Budget

HUD is currently finishing Congressional justifications for its proposed FY2010 budget. On Friday, March 20, Secretary Donovan has invited Members of Congress to breakfast at the White House's request, to allay concerns that some Members may have over the President's proposed FY2010 budget.

#### Middle Class Task Force

On Thursday, March 19, Secretary Donovan participated in the second meeting of the Middle Class Task Force, in St. Cloud, Minnesota. The Secretary highlighted how HUD's implementation of the American Recovery and Reinvestment Act will help middle class families, and provide the housing stability necessary to give lower-income families a pathway to the middle class.

# Personnel

This week we announced President Obama's intent to nominate Raphael Bostic as Assistant Secretary for Policy Development and Research. Dr. Bostic is a Professor in USC's School of Policy, Planning, and Development. He studies the roles that credit markets, financing, and policy play in enhancing

household access to economic and social amenities. Dr. Bostic is an expert on housing and homeownership, and has extensively studied the roles that credit markets, financing, and policy play in enhancing household access to economic and social amenities. He is also currently studying the effects of community development financial institutions on neighborhood well-being, how anti-predatory lending laws impact credit flows, and the role of the private label secondary market in facilitating the flow of capital to subprime and possibly predatory loans.

In addition, we announced Carol Galante as Deputy Assistant Secretary for Multi-Family Housing Programs. Galante is currently the President of BRIDGE Housing Corporation, the largest nonprofit developer of affordable apartments and homes in California, specializing in the development of family and senior affordable apartments, rental and ownership housing, and an array of revitalization, transit-oriented, urban infill, and mixed-use/mixed-income developments. As Deputy Assistant Secretary, Galante will be responsible for HUD's financing support for the development of rental housing (a current portfolio of over \$56 billion) and will be integral to several new initiatives that promote sustainable development.

We continue to add to the political appointment slate at HUD. We have identified and/or hired 32 of the 49 schedule C positions and 5 of the 12 SES positions allotted to the agency.

The Secretary will be in Argentina on personal travel next week, then holding meetings with Argentine officials on March 26 and 27.

# **FHA Testimony**

#### 100 Day Report

# Continued Progress on HUD/DOL Green Jobs Partnership

The proposal outlines next steps on connecting One-Stop job centers with Public Housing Authorities, and a number of existing DOL and HUD programs that we can use for a proposed "green jobs" pilot. HUD has also shared with DOL our data on public, assisted, and tax credit housing, by census tract and including demographic characteristics (e.g. whether the residents are working-age), to merge with their One-Stop data and determine where pockets of HUD residents can be served by One-Stop centers.

HUD has begun internal meetings to brainstorm specific locations for the pilot, and think about how our existing programs could be adapted to create a clear process for moving public housing residents into training programs, and eventually into green jobs.

We are hopeful that the committee will vote on their nominations next week.

#### Research Support

HUD has begun working with a consortium of leading philanthropies, including the MacArthur Foundation, the Rockefeller Foundation, and the Ford Foundation, and thought leaders like the Brookings Institution, the Furman Center at New York University, and the Joint Center for Housing Studies at Harvard to determine how they can provide support to HUD's senior team through short- and long-term research projects in key areas, including foreclosure, housing finance reform, and sustainability.

#### **Budget Rollout**

HUD is working with OMB and Legislative Affairs to determine the proper protocol for Hill notifications and meetings prior to and following the release of the HUD budget on May 5. After the release of the President's budget, HUD will convene its first large meeting of major HUD stakeholders to highlight the new course for the agency set by the FY 2010 budget.

# Press Update

This week, Secretary Donovan spoke to the National Low Income Housing Coalition and participated in an Earth Day event with Mayor Fenty, where he highlighted how Recovery funds are being used to increase energy efficiency and cost savings at public housing properties.

On Monday, April 27, Secretary Donovan will do an interview with Diana Olick of CNBC. On Friday, May 1, Secretary Donovan will tape a C-SPAN "Newsmakers" interview.

# DC Summer Youth Employment Program

At the request of the White House, HUD has confirmed that we will commit to accepting summer interns from the DC Summer Youth Employment Program this summer, and helping the President and First Lady reach their goal of offering public service summer employment to 1,000 DC youth through the agencies and other federal government entities.

# Chief of Staff Off-Site Meeting

On Saturday, April 25, HUD Chief of Staff Laurel Blatchford will present at the Chiefs of Staff off-site meeting on eliminating popular programs that don't work.

**Budget Rollout** 

HUD has prepared a detailed budget rollout strategy. As determined in consultation with the White House, on May 6 we will be conducting a targeted briefing for key appropriations staff. At a time to be determined in consultation with the White House, we will hold a press conference and budget briefing for the media, to be followed by separate briefings for House staff, Senate staff, and HUD stakeholders.

# Making Home Affordable

On April 28, the Administration announced new efforts to assist struggling homeowners under the Making Home Affordable Program. These new solutions are intended to help make mortgages more affordable under the President's housing plan. The plan includes a Second Lien Program that complements the first lien modification program. This initiative is projected to reach up to 1.5 million homeowners and could potentially further reduce payments for up to 50% of participants in the Home Affordable Modification Program by lowering or extinguishing payments on second liens. In addition, the Administration will incorporate FHA's Hope for Homeowners Program into the Making Home Affordable Program. This will make it easier for underwater borrowers to modify or refinance their loans and regain equity in their homes.

On April 30, the Senate is expected to begin consideration of S. 896 – Helping Families Save Their Homes Act of 2009 – which will strengthen the Hope for Homeowners Programs so that it can function more effectively as an integral part of the Making Home Affordable Program.

This week, two servicers signed contracts to participate in the \$75 billion loan modification portion of Making Home Affordable: Carrington Mortgage Servicing and Green Tree Servicing – bringing the total number of servicers formalizing their commitments under the program to 13.

# Weatherization Collaboration with DOE

OMB currently has the HUD/DOE weatherization collaboration rule and MOU, and is seeking resolution on interpretation of DOE Weatherization program statute. Upon OMB approval, we expect to announce next week a Memorandum of Understanding with the Department of Energy that will make HUD's public and assisted housing stock (3 million housing units) categorically eligible for DOE's weatherization program.

# Personnel

On Tuesday, April 28th, Senator Chris Dodd (D CT), Chairman of the Senate Committee on Banking, Housing and Urban Affairs, announced that the Committee confirmed the nominations of four HUD Assistant Secretary nominees. The following four nominees passed the Committee by voice vote, and will now be reported to the full Senate for its consideration: The Honorable Ronald Sims (Deputy Secretary-Designate), Ms. Helen R. Kanovsky (General Counsel Designate), Mr. Peter Kovar (Assistant Secretary for Congressional and Intergovernmental Affairs Designate), and Mr. John D. Trasviña (Assistant Secretary for Fair Housing and Equal Opportunity Designate)

#### Press Update

This week, Secretary Donovan participated in a press conference in NYC with Mayor Bloomberg and local elected officials to announce Recovery Act funding for public housing, and then attended Congressman Rangel's Economic Recovery Conference for non-profit leaders to discuss HUD's Recovery Act funds and implementation.

On Tuesday, April 28, the Secretary participated in a roundtable discussion with key housing reporters to discuss the administration's housing plan, the first 100 days in office and his vision for HUD's future. On Wednesday, he did radio and TV interviews to further outline the administration's 100 days messaging, and then participated in the Reuters Global Financial Regulation Summit's roundtable discussion with reporters. He also spoke to the Mortgage Bankers Association about Recovery Act funding and the housing plan. On Friday, May 1, he will tape a C SPAN "Newsmakers" interview.

#### CDBG Disaster Fund Allocation

HUD has finalized a formula to allocate the final \$3.9 billion of the \$6.5 billion appropriation for disaster relief through CDBG. This allocation is to 10 states that represent 97 percent of the estimated unmet needs across the 76 disasters that occurred in 2008. The allocation was based on the sum of estimated unmet needs and a HUD-calculated risk level for difficulty of recovery. Additionally, to nurture effective new strategies for disaster relief, HUD has established a \$200 million incentive fund for grantees that undertake forward-thinking recovery strategies in a timely manner.

The allocation of these funds has been of particular interest to lowa and Texas. Iowa Governor Culver, as well as members of the State's Congressional delegation, have met with Secretary Donovan and HUD staff on the importance of these funds to the State's recovery efforts. The amount of funding awarded to lowa closely aligns with the State's calculated need and stated expectation.

HUD will meet with the White House Offices of Cabinet Affairs, Legislative Affairs, and Intergovernmental Affairs on Tuesday, May 5th to discuss the process and strategy for notifications of this funding announcement. Based on the outcome and direction of this meeting, HUD will set a schedule for notifications and a general communications strategy.

# Recruitment/Reform

On Thursday, April 30, Secretary Donovan conducted a one-hour webcast with over 40 undergraduate, public policy, law, and business schools to recruit the best young talent. The goal of the webcast was to build long-term recruiting relationships with top-flight schools, and ultimately to recruit talent to fill more than 550 full-time HUD positions. The call was facilitated/co-hosted with the Partnership for Public Service and highlighted the experience of a recent young hire, described transformation initiatives underway, and outlined specific job opportunities and the HUD hiring process
