This is in response to your letter dated 27 December 2009, received in the Information Management Services Center of the National Reconnaissance Office (NRO) on 5 January 2010. Pursuant to the Freedom of Information Act (FOIA), you are requesting a copy of *"the IG investigations closed since October 1, 2008."*

Your request was processed in accordance with the Freedom of Information Act, 5 U.S.C. § 552, as amended. A thorough search of our files and databases located three pages responsive to your request. These records are being released to you in part.

These records are being released to you with portions withheld pursuant to FOIA exemption (b)(1) as properly classified information under Executive Order 13526, Section 1.4(c); and exemption (b)(2), which pertains solely to the internal rules and practices of an agency and allows the withholding of information which, if released, would allow circumvention of an organization rule, policy, or statute, thereby impeding the agency in the conduct of its mission.

The FOIA authorizes federal agencies to assess fees for record services. Based upon the information provided, you have been placed in the "other" category of requesters, which means you are responsible for the cost of search time exceeding two hours (\$44.00/hour) and reproduction fees (.15 per page) exceeding 100 pages.
