This letter responds to your Freedom of Information Act request, case number 2010-03-044 for the listing of mandatory declassification review requests at the Department of the Treasury. The listing of largely closed cases extends back to 2001.

The blacked-out parts have been withheld under 5 U.S.C. § 552(b) (6) which exempts from disclosure "personnel and medical files and similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy."

This is a partial denial of your request. You may appeal this decision within 35 days from the date of this letter. Your appeal must be in writing, signed by you, and should be addressed to:
