This is the electronic final response to your March 31, 2020, Freedom of Information Act (FOIA) request to the Department of Homeland Security (DHS) for a copy of the three page record on the DHS employee intranet site called "called "FOIA Employee Useful Links and Information" related to FOIA information. This office received your request on April 1, 2020 as amended on December 22, 2020.

In responding to a FOIA request, DHS will search for responsive documents in its control on the date the search began. We began our search on June 11, 2020. A search of the Privacy Office for documents responsive to your request produced a total of 3 pages.

We are granting your request under FOIA, 5 U.S.C. § 552, and DHS FOIA regulations at 6 C.F.R. Part 5. After carefully reviewing the responsive document, I determined that it is appropriate for public release. The documents are enclosed in their entirety; DHS has claimed no deletions or exemptions.

Provisions of FOIA allow DHS to charge for processing fees, up to \$25, unless you seek a waiver of fees. In this instance, because the cost is below the \$25 minimum, there is no charge.
