This letter responds to your Freedom of Information Act (FOIA) request dated June 10, 2019, addressed to the Transportation Security Administration (TSA) FOIA Branch seeking access to "a copy of each email in the email account of Terri Miller, TSA FOIA Officer, during the time period April 22, 2019 through the present, that contains the word CREW."

The processing of your request identified certain records that will be released to you. Portions not released are being withheld pursuant to the Freedom of Information Act, 5 U.S.C. § 552. Hi Teri,

To follow up on our conversation last week on TSA's Certification of Identity form, the information TSA collects on the form sent to FOIA requesters is both required by the DHS Privacy Act regulations, found at 6 CFR Part 5, Subpart B, and permissible under the Privacy Act. (b)(5)

Specifically, 5 CFR 5.21(d) states:

(d) Verification of identity. When you make a request for access to records about yourself, you must verify your identity. *You must state* your full name, current address, and date and place of birth. *You must* sign your request and your signature *must either* be notarized or submitted by you under 28 U.S.C. 1746, a law that permits statements to be made under penalty of perjury as a substitute for notarization. While no specific form is required, you may obtain forms for this purpose from the Departmental Disclosure Officer, Department of Homeland Security, Washington, DC 20528. In order to help the identification and location of requested records, you may also, at your option, include your social security number. (emphasis added)

Good morning Michelle,



Hello,

There seems to be some confusion with regards to the FOIA Affirmation/Declaration form and why it's no longer "required"? To be clear, we'll still be reaching out to the requester for the purpose of verifying their identity when needed. However, to cut down on confusion, I've decided going forward, the FOIA staff will take care of this step.

The FOIA regulations state that an individual seeking records on themselves or representing a third-party must provide certain information under penalty of perjury to gain greater access to records. Therefore, TSA, DOJ and many other agencies have their own certification of identity form for the requester to fill out which contains all of the fields required as outlined in the regs. However, the requester isn't "required" to use the form. They can either provide the required information in writing and attest under penalty of perjury they are who they say they are; or, provide a document stating that they have permission from an individual to receive their records; or, provide all of the required information in a notarized statement. Therefore, we are adjusting our language in our form letters, emails and on the website to suggest use of the form rather than require its use.

For additional insight into this matter, please see the attached email to the DHS Privacy office. This email was a result of my consultation with TSA's Chief Counsel's office, Information Law. They are the legal review authority over TSA's FOIA requests.



Citizens for Responsibility and Ethics in Washington ("CREW") makes this request for records pursuant to the Freedom of Information Act ("FOIA"), 5 U.S.C. § 552, and Transportation Security Administration ("TSA") regulations.

First, CREW requests copies of all communications between Chad Wolf, then-Vice president at Wexler | Walker, and any official at TSA within the Office of the Administrator, the Office of Security Operations, or the Office of Enterprise Support between January 20, 2016 and January 20, 2017.

Second, CREW requests copies of all communications between Chad Wolf, an official at TSA, and the following employees at Wexler | Walker and/or Hill+Knowlton, including: Jody Hoffman, Natalie Nehme, George Rogers, Dale Snape, Patrice Stanley, Robert Walker, and Daniel Wexler between January 20, 2017 and August 20, 2017.

Third, CREW requests copies of all communications to or from Chad Wolf, an official at TSA, mentioning or pertaining to the following employees at Wexler | Walker and/or Hill+Knowlton, including: Jody Hoffman, Natalie Nehme, George Rogers, Dale Snape, Patrice Stanley, Robert Walker, and Daniel Wexler between January 20, 2017 and August 20, 2017.

Please search for responsive records regardless of format, medium, or physical characteristics. We seek records of any kind, including paper records, electronic records, audiotapes, videotapes, photographs, data, and graphical material. Our request includes without limitation all correspondence, letters, emails, text messages, facsimiles, telephone messages, voice mail messages, and transcripts, notes, or minutes of any meetings, telephone conversations, or discussions. Our request also includes any attachments to emails and other records, as well as those who were cc'ed or bcc'ed on any emails.

If it is your position any portion of the requested records is exempt from disclosure, CREW requests that you provide it with an index of those documents as required under *Vaughn v. Rosen*, 484 F.2d 820 (D.C. Cir. 1973). If some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. *See* 5 U.S.C. § 552(b). If it is your position that a document contains non-exempt segments, but that those non-exempt segments are so dispersed throughout the document as to make segregation impossible, please state what portion of the document is non-exempt, and how the material is dispersed throughout the document. *See Mead Data Central v. U.S. Dep't of the Air Force*, 566 F.2d 242, 261 (D.C. Cir. 1977).

# Fee Waiver Request

In accordance with 5 U.S.C. § 552(a)(4)(A) and TVA regulations, CREW requests a waiver of fees associated with processing this request for records. The subject of this request concerns the operations of the federal government, and the disclosures likely will contribute to a better understanding of relevant government procedures by CREW and the general public in a significant way. See 5 U.S.C. § 552(a)(4)(A)(iii). Moreover, the request primarily and fundamentally is for non-commercial purposes. See, e.g., McClellan Ecological v. Carlucci, 835 F.2d 1282, 1285 (9th Cir. 1987).

Prior to joining the Trump Administration, Chad Wolf worked as a vice president at the lobbying firm Wexler | Walker. Mr. Wolf left Wexler | Walker in January 2017 and became Chief of Staff at TSA shortly thereafter. According to public reports, during his tenure at the firm, Wolf lobbied TSA directly, and tried to persuade the agency to spend millions of dollars on a carry-on luggage screening device on behalf of an industry client. After a brief stint as TSA Chief of Staff, Wolf was promoted to Deputy Chief of Staff and then Chief of Staff at the Department of Homeland Security (DHS). In February 2019, President Trump announced his intention to nominate Wolf to be the Under Secretary for Strategy, Policy and Plans at DHS.

During his tenure at DHS, several of Wolf's former lobbying firm colleagues have lobbied the agency.<sup>5</sup> The requested records will shed light on the extent to which Wolf's former colleagues have lobbied him during his tenure at TSA and DHS and if Wolf responded to any such overtures. This information is also relevant to how TSA and DHS monitor compliance with relevant ethical standards including, but not limited to, ethics agreements and the Trump Administration ethics pledge, codified in Executive Order 13770. The public is entitled to know

CREW uses a combination of research, litigation, and advocacy to advance its mission. CREW intends to analyze the information responsive to this request and to share its analysis with the public through reports, press releases, or other means. In addition, CREW will disseminate any documents it acquires from this request to the public through its website, <a href="www.citizensforethics.org">www.citizensforethics.org</a>, and through <a href="www.scribd.com">www.scribd.com</a>. The release of information obtained through this request is not in CREW's financial interest.

CREW further requests that it not be charged search or review fees for this request pursuant to 5 U.S.C. § 552(a)(4)(A)(ii)(II) because CREW qualifies as a member of the news media. See Nat'l Sec. Archive v. U.S. Dep't of Defense, 880 F.2d 1381, 1386 (D.C. Cir. 1989) (holding non-profit a "representative of the news media" and broadly interpreting the term to include "any person or organization which regularly publishes or disseminates information to the public").

CREW routinely and systematically disseminates information to the public in several ways. CREW's website receives tens of thousands of page views every month. The website includes blogposts that report on and analyze newsworthy developments regarding government ethics, corruption, and money in politics, as well as numerous reports CREW has published to educate the public about these issues. In addition, CREW posts documents it receives under the FOIA on its website, and those documents have been visited hundreds of thousands of times.

Under these circumstances, CREW satisfies fully the criteria for a fee waiver.

On April 22, 2019, I submitted by email a Freedom of Information Act ("FOIA") request to your office on behalf of Citizens for Responsibility and Ethics in Washington ("CREW"). The request was clearly identified as a FOIA request and sought three categories of records concerning or mentioning communications between Transportation Security Administration ("TSA") official Chad Wolf and his previous firm as well as other identified individuals and entities. In support of CREW's request for a fee waiver I explained that the requested information will shed light on the extent to which Mr. Wolf's former colleagues have lobbied him during his tenure at TSA and the Department of Homeland Security. A copy of this request is enclosed as Exhibit A.

By email dated April 22, 2019, and sent at 1:45 p.m., the TSA Contact Center advised me that CREW's FOIA request was incomplete because I failed to include a signed copy of TSA's Affirmation/Declaration form, which the email stated, "is required if you are seeking records on behalf of yourself or a third party." A copy of this email is enclosed as Exhibit B. The referenced form requires me to provide, *inter alia*, my date and place of birth and my citizenship status. It also asks me to indicate my understanding "that any applicable fees must be paid by me," and requires me to execute the form under penalty of perjury.

The additional requirements TSA seeks to impose on CREW before it will treat CREW's FOIA request as perfected exceed and conflict with what the FOIA itself requires and raise a substantial risk of chilling requests by CREW and others. There simply is no reason why TSA needs information about my date and place of birth or my citizenship status to process CREW's FOIA request, which has not been made under the Privacy Act. Nor is it appropriate to ask me to acknowledge my personal liability for fees when CREW has demonstrated its entitlement to a fee waiver.

In my many years of submitting FOIA requests on behalf of CREW I have never before been requested to submit this kind of information. Its unprecedented nature highlights just how at odds the request for this information is with the FOIA, a statute intended to enhance agency transparency and accountability. Accordingly, please be advised that CREW will not be submitting a signed Affirmation/Declaration form and considers its request, which complies fully with the FOIA, to be perfected as is and as of the date of submission, April 22, 2019.

Finally, even if TSA submitted this demand for an Affirmation/Declaration form in error, it raises substantial concerns that an agency like TSA is amassing personal data about FOIA requesters. CREW is an experienced FOIA requester able to identify the impropriety of asking a FOIA requester for personal data like their date and place of birth and citizenship status. Other less experienced members of the public may not realize the illegitimacy of TSA's request. Given the implications of the unauthorized collection of personal data concerning FOIA requesters, TSA must take appropriate steps to ensure such a mistake is not repeated.

Please advise me as soon as possible if you disagree with our position that CREW has already submitted a perfected request so that we can promptly pursue all available legal remedies.



# Fee Waiver Request

In accordance with 5 U.S.C. § 552(a)(4)(A) and TVA regulations, CREW requests a waiver of fees associated with processing this request for records. The subject of this request concerns the operations of the federal government, and the disclosures likely will contribute to a better understanding of relevant government procedures by CREW and the general public in a significant way. See 5 U.S.C. § 552(a)(4)(A)(iii). Moreover, the request primarily and fundamentally is for non-commercial purposes. See, e.g., McClellan Ecological v. Carlucci, 835 F.2d 1282, 1285 (9th Cir. 1987).

Prior to joining the Trump Administration, Chad Wolf worked as a vice president at the lobbying firm Wexler | Walker. Mr. Wolf left Wexler | Walker in January 2017 and became Chief of Staff at TSA shortly thereafter. According to public reports, during his tenure at the firm, Wolf lobbied TSA directly, and tried to persuade the agency to spend millions of dollars on a carry-on luggage screening device on behalf of an industry client. After a brief stint as TSA Chief of Staff, Wolf was promoted to Deputy Chief of Staff and then Chief of Staff at the Department of Homeland Security (DHS). In February 2019, President Trump announced his intention to nominate Wolf to be the Under Secretary for Strategy, Policy and Plans at DHS.

During his tenure at DHS, several of Wolf's former lobbying firm colleagues have lobbied the agency.<sup>5</sup> The requested records will shed light on the extent to which Wolf's former colleagues have lobbied him during his tenure at TSA and DHS and if Wolf responded to any such overtures. This information is also relevant to how TSA and DHS monitor compliance with relevant ethical standards including, but not limited to, ethics agreements and the Trump Administration ethics pledge, codified in Executive Order 13770. The public is entitled to know

whether key decisions at TSA and DHS are impacted by lobbyists and special interests who gain access through former employees now in government positions.

CREW is a non-profit corporation, organized under section 501(c)(3) of the Internal Revenue Code. CREW is committed to protecting the public's right to be aware of the activities of government officials, to ensuring the integrity of those officials, and to highlighting and working to reduce the influence of money on politics. CREW uses a combination of research, litigation, and advocacy to advance its mission. CREW intends to analyze the information responsive to this request and to share its analysis with the public through reports, press releases, or other means. In addition, CREW will disseminate any documents it acquires from this request to the public through its website, <a href="www.citizensforethics.org">www.citizensforethics.org</a>, and through <a href="www.scribd.com">www.scribd.com</a>. The release of information obtained through this request is not in CREW's financial interest.

CREW further requests that it not be charged search or review fees for this request pursuant to 5 U.S.C. § 552(a)(4)(A)(ii)(II) because CREW qualifies as a member of the news media. See Nat'l Sec. Archive v. U.S. Dep't of Defense, 880 F.2d 1381, 1386 (D.C. Cir. 1989) (holding non-profit a "representative of the news media" and broadly interpreting the term to include "any person or organization which regularly publishes or disseminates information to the public").

CREW routinely and systematically disseminates information to the public in several ways. CREW's website receives tens of thousands of page views every month. The website includes blogposts that report on and analyze newsworthy developments regarding government ethics, corruption, and money in politics, as well as numerous reports CREW has published to educate the public about these issues. In addition, CREW posts documents it receives under the FOIA on its website, and those documents have been visited hundreds of thousands of times.

Under these circumstances, CREW satisfies fully the criteria for a fee waiver.
