This letter is in response to your Freedom of Information Act (FOIA) request to the Alcohol and Tobacco Tax and Trade Bureau (TTB) dated February 4, 2021. You are requesting a copy of the following pages from the TTB Alcohol Label and Formula Divison (ALFD) internal website:

- 1) ALFD Assignment Database;
- 2) ALFD Project List;
- 3) ALFD Statistical Data;
- 4) ALFD Training;
- 5) Accelerated Review;
- 6) ALFD-BSC; and
- 7) DS-BSC Initiative.

We conducted a search of files within TTB for records responsive to your request and identified 7 pages which are being released in part, with information exempt from disclosure under the FOIA having been redacted pursuant to 5 U.S.C. 552 (b)(6).

FOIA exemption 6 protects from disclosure personnel and similar files, including names, signatures, images, and/or contact information of certain individuals, the disclosure of which would constitute an unwarranted invasion of privacy.

Enclosed is a Document Cover Sheet with your appeal rights outlined on the reverse side. If you choose to appeal this response, you must do so within 90 days from the date of this letter.

Please note that a FOIA Public Liaison is available if you would like to discuss any issues regarding a FOIA response. A FOIA Public Liaison is a supervisory official with the Department of the Treasury to whom FOIA requesters can raise questions or concerns about the agency's FOIA process.
