This letter is in response to your Freedom of Information Act (FOIA) request, dated December 26, 2020, sent to the U.S. Department of Transportation (DOT), Office of Inspector General (OIG). You requested the following records:

"A copy of the list of Dept of Transportation Office of Inspector General investigations CLOSED during Calendar Year 2020. If this request has been directed to the wrong office, please refer it to the correct office."

Enclosed are a total of seven (7) pages of documents responsive to your request. Some information was redacted or withheld pursuant to exemptions provided by the FOIA (5 U.S.C. § 552 (b)(6), (b)(7)(c) & (b)(7)(e)) $^{1}$ .

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. 552(c) (2006 & Supp. IV 2010). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

<sup>1</sup> Exemption 6 protects names and any data-identifying individuals if public disclosure would be a clearly unwarranted invasion of privacy. Exemption 7(C) protects personal information in law enforcement records. It prevents the disclosure of law enforcement information that could reasonably constitute an unwarranted invasion of personal privacy. Exemption 7(E) protects techniques/procedures used in law enforcement investigations or prosecutions from disclosure. It prevents the disclosure of guidelines for law enforcement investigations or prosecutions if disclosure could reasonably be expected to risk circumvention of the law.

The Chief Counsel's determination will be administratively final.
