When I arrived for my interview I was asked by the agent who conducted it if I had a college degree. I told him I did not. I was told that it is not required to have one, but all special agents have college degrees. I asked if I could continue in the hiring process even though I did not have a degree. I was told I could, but even if I advanced through the process, at the final stage of selection, I would not be selected over a candidate with a college degree. A short time later I completed an interview conducted by the same agent. I understand that the results of my interview are subjective, therefore I worry that his decision was negatively influenced by preconceived biases of individuals who do not have college degrees. I would like to hear back from you or someone else from your agency who can provide me with more information as to why I did not pass.
