## Re: Freedom of Information Act Request 04-41

This is in response to your August 20, 2004 Freedom of Information Act (FOIA) request, in which you requested "a list of the investigations closed between January 1, 2003 and the present." Your request was received in this office on September 1, 2004.

Enclosed please find a log responsive to your request, from which certain information has been redacted. The redacted information includes personal information relating to persons other than yourself, which is being withheld under Exemption 7(C) of the FOIA, 5 U.S.C. § 552(b)(7)(C). Release of this information could reasonably be expected to constitute an unwarranted invasion of the personal privacy of the persons mentioned in the records. The redacted information also includes information pertaining to *qui tam* actions filed under the provisions of the civil False Claims Act, 31 U.S.C. § 3729-3731. This information is being withheld under exemption 3(A) of the FOIA, 5 U.S.C. § 552(b)(3)(A), which exempts from disclosure information specifically exempted by statute. Withholding of this information is specifically required by 31 U.S.C. § 3730(b)(2), which provides that *qui tam* complaints be filed under seal and shall remain under seal until the court orders otherwise.

You have the right to appeal for disclosure of the redacted information by writing to the Freedom of Information Act Officer, Office of the Inspector General, General Services Administration, Washington, D.C. 20405, within 120 days of your receipt of this letter. The appeal must be in writing and contain a statement of reasons for the appeal. Please enclose copies of your initial request and this response. The envelope and letter should be clearly marked as a "Freedom of Information Act Appeal."
