We searched for, and located, 163 pages of records that are responsive to your request.


Of the 163 pages located in response to your request, we're enclosing 163 pages. We're releasing 2 pages without exemptions, and we're withholding 161 pages in part. Redacted portions of each page are marked by the applicable FOIA exemptions which is described below:


FOIA exemption (b)(6) exempts from disclosure files that would constitute an unwarranted invasion of personal privacy. We base the determination to withhold on balancing interests between the protection of an individual's right to privacy and the public's right to access government information.
