This responds to your revised Freedom of Information Act (FOIA) request of 14 January 1994 for "FOIA Case Log 1992 only" (narrowed to exclude Privacy Act (PA) requests). In keeping with your August 2003 phone conversation with Pamela Phillips, Chief of the FOIA/PA Office, the requested Case Log will only include direct requests. For purposes of this request and based on the information you provided in your letter, you are considered an "all other" requester. As such, you are allowed two hours of search and the duplication of 100 pages at no cost. There are no assessable fees for this request. A copy of your request is enclosed. Your request has been processed under the FOIA and the documents (48 pages) you requested are enclosed. Certain information, however, has been deleted from the enclosures.

Information regarding some individuals has been deleted from the enclosure in accordance with 5 U.S.C. 552 (b)(6). This exemption protects, from disclosure, information which would constitute a clearly unwarranted invasion of personal privacy. In balancing the public interest for the information you request against the privacy interests involved, we have determined that the privacy interests sufficiently satisfy the requirements for the application of the (b)(6) exemption.

In addition, this Agency is authorized by statute to protect certain information concerning its activities and the names of its employees. Such information is exempt from disclosure pursuant to the third exemption of the FOIA which provides for the withholding of information specifically protected from disclosure by statute. The specific statute applicable in this case is Section 6, Public Law 86-36 (50 U.S. Code 402 note). We have determined that such information exists in these records, and we have excised it accordingly.

Since these deletions may be construed as a partial denial of your request, you are hereby advised of this Agency's appeal procedures. Any person denied access to information may file an appeal to the NSA/CSS Freedom of Information Act Appeal Authority. The appeal must be postmarked no later than 60 calendar days from the date of the initial denial letter. The

appeal shall be in writing addressed to the NSA/CSS FOIA Appeal Authority (DC321), National Security Agency, 9800 Savage Road STE 6248, Fort George G. Meade, MD 20755-6248. The appeal shall reference the initial denial of access and shall contain, in sufficient detail and particularity, the grounds upon which the requester believes release of the information is required. The NSA/CSS Appeal Authority will endeavor to respond to the appeal within 20 working days after receipt, absent any unusual circumstances.

Information has also been deleted from the document as Non-Responsive if the entries are not direct FOIA requests, as agreed to in your clarification.

A document explaining the case dispositions is also included for your use.




