RE: Your FOIA Request to Treasury, Case Number 2017-09-227

This is the final response of the Department of the Treasury (Treasury) to your Freedom of Information Act (FOIA) request dated 9/21/2017. You have requested access to the following records:

“A digital/electronic copy of the Secretary's Visit Book for the most recent three international trips by the Treasury Secretary (during 2017). The Visit Book is a Binder containing the preparation and planning logistics relating to specific trips made by the Secretary as an official of the U.S. Government to foreign countries. The material includes line by line details relating to scheduled events, costs, phone contact lists, manifest, accommodations, weather, required dress, and other relevant information for the intended event and locale.”

Your request has been processed under the provisions of the FOIA, 5 U.S.C. § 552. A reasonable search was conducted for records responsive to your request. In response to the search, 40 pages were located within the Departmental Offices of Treasury. After carefully considering these records, I am releasing 6 pages in full and 34 pages in part. The withheld information is protected from disclosure under the FOIA pursuant to Exemptions (b)(5), (b)(6), (b)(7)(c) and (b)(7)(E). There are no fees assessed at this time since allowable charges fell below \$25.

Exemption (b)(5), exempts from disclosure “inter-agency or intra-agency memoranda or letters which would not be available by law to a party other than an agency in litigation with the agency.”

Exemption (b)(6), permits withholding of records and information about individuals when disclosure would be a clearly unwarranted invasion of personal privacy.

Exemption (b)(7)(C), provides protection for law enforcement information the disclosure of which “could reasonably be expected to constitute an unwarranted invasion of personal privacy.” This exemption is the law enforcement counterpart to Exemption 6.

Exemption (b)(7)(E), Permits withholding of records when techniques and procedures for law enforcement investigations or process would be disclosed or provided such disclosure could reasonably be expected to risk circumvention of law.

You have the right to appeal this decision within 90 days from the date of this letter. By filing an appeal, you preserve your rights under FOIA and give the agency a chance to review and reconsider your request and the agency's decision. Your appeal must be in writing, signed by you or your representative, and should contain the rationale for your appeal. Please also cite the FOIA reference number noted above. If you submit your appeal by mail, clearly mark the letter and the envelope with the words "Freedom of Information Act Appeal." Your appeal must be postmarked or electronically transmitted within 90 days from the date of this letter.

If you would like to discuss this response before filing an appeal to attempt to resolve your dispute without going through the appeals process, you may contact our FOIA Public Liaison for assistance via email at FOIAPL@treasury.gov, or via phone at (202) 622-8098. A FOIA Public Liaison is a supervisory official to whom FOIA requesters can raise questions or concerns about the agency's FOIA process. FOIA Public Liaisons can explain agency records, suggest agency offices that may have responsive records, provide an estimated date of completion, and discuss how to reformulate and/or reduce the scope of requests in order to minimize fees and expedite processing time.

If the FOIA Public Liaison is unable to satisfactorily resolve your question or concern, the Office of Government Information Services (OGIS) also mediates disputes between FOIA requesters and federal agencies as a non-exclusive alternative to litigation.
