This letter is in response to your January 26, 2021, Freedom of Information Act (FOIA) request submitted electronically to the FOIA Officer for AmeriCorps. You requested "[a] copy of the listing of investigations closed during the time period Calendar Years 2014 - 2019 (inclusive)."

The AmeriCorps (formerly CNCS) FOIA Office referred your request to this office for processing on January 26, 2021, as the matter relates to records under AmeriCorps Office of Inspector General (AmeriCorps OIG) (formerly CNCS-OIG) jurisdiction and control.

As requested, please find the attached list of closed AmeriCorps OIG investigations during calendar years 2014-2019. Personally identifiable information, including the identities of individuals and any other identifying information in the released records, have been redacted based on Exemptions 6 and 7(C) of the FOIA, 5 U.S.C. § 552(b)(6) and (b)(7)(C). Exemption 6 authorizes the withholding of "personnel and medical files and similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy." Exemption 7(C) authorizes the withholding of "records or information compiled for law enforcement purposes . . . to the extent that production of such law enforcement records or information . . . could reasonably be expected to constitute an unwarranted invasion of personal privacy."

If you are dissatisfied with my action on this request, you may appeal by writing to Fara Damelin, Deputy Inspector General, Corporation for National and Community Service, Office of Inspector General, 250 E Street SW, Suite 4100, Washington, DC 20525, or at f.damelin@cncsoig.gov, within 90 days of your receipt of this letter. In the event you are dissatisfied with the results of any such appeal, judicial review is available to you in the United States District Court for the judicial district in which you reside, or in the District of Columbia, which is where the records you seek are located.

As an alternative to judicial review, the Office of Government Information Services (OGIS) offers mediation services to resolve disputes between FOIA requesters and Federal agencies as a non-exclusive alternative to litigation. Using OGIS does not affect your right to pursue litigation.
