Re: Final Response to Freedom of Information Act (FOIA) Request No. 2021-03721

This is the final response to your FOIA request dated June 16, 2021 to the U.S. Office of Personnel Management (OPM), assigned tracking number 2021-03721. You requested the following:

“A copy of each OPM letter or OPM ‘View(s)’ Letter to Congress regarding proposed legislation to establish a national Juneteenth holiday, (this bill has been referenced as S 475 and/or HR 1320). A copy of all records at OPM regarding the proposed Juneteenth federal holiday. You may limit this request to records during the time period January 1, 2020 to the present.”

Your request was processed under the FOIA, 5 U.S.C. § 552.

OPM’s Employee Services (ES) and Congressional, Legislative, and Intergovernmental Affairs (CLIA) offices performed searches for responsive records. ES located no records responsive to your request. CLIA located seventy-five (75) pages of responsive records. There are no responsive records for the part of the request seeking OPM ‘View(s)’ Letters to Congress, as OPM did not provide such.

Upon review, OPM has determined to partially withhold certain records, pursuant to FOIA Exemptions 5 and 6, 5 U.S.C. § 552(b)(5) and (b)(6), described below. Redactions have been placed on the withheld information and indicate the exemption(s) applied.

Exemption 5

Exemption 5 allows an agency to withhold “inter-agency or intra-agency memorandums or letters which would not be available by law to a party . . . in litigation with the agency.” 5 U.S.C. § 552(b)(5). As a threshold matter, the information being withheld is intra-agency because it was exchanged within OPM as well as inter-agency because it was also exchanged between OPM and other federal executive government agencies.

Deliberative Process Privilege

The deliberative process privilege protects the decision-making process of government agencies to encourage the frank exchange of ideas on policy matters, protect against the premature disclosure of proposed policies before they are actually adopted, and protect against public confusion that might result from disclosure of reasons and rationales that were not ultimately the grounds for an agency's action. Information must be both predecisional and deliberative. The information that has been withheld under the deliberative process privilege is both predecisional and deliberative. It is predecisional because it is antecedent to the adoption of an agency policy. It is also deliberative because it reflects the give-and-take of the consultative process.

Attorney-Client Privilege

The attorney-client privilege protects confidential communications between an attorney and his client relating to a legal matter for which the client has sought professional advice and is not limited to the context of litigation. This privilege also encompasses any opinions given by an attorney to his/her client based upon, and thus reflecting, those facts, as well as communications between attorneys that reflect confidential client-supplied information.

Exemption 6

Exemption 6 allows an agency to withhold "personnel and medical files and similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy." 5 U.S.C. § 552(b)(6). The phrase "similar files" covers any agency records containing information about a particular individual that can be identified as applying to that individual. The privacy interest that would be affected by disclosure must be balanced against any public interest in the information. Under the FOIA, the only relevant public interest to consider is the extent to which the information sought would shed light on an agency's performance of its statutory duties or otherwise let citizens know what their government is up to.

The information that has been withheld under Exemption 6 consists of personal files in which individuals have a substantial privacy interest. OPM has determined that the disclosure of this information would shed little or no light on the operations of the government. Because the harm to personal privacy is greater than whatever public interest may be served by disclosure, release of the information would constitute a clearly unwarranted invasion of privacy.

An appeal should include a copy of the initial request, a copy of the letter denying the request, and a statement explaining why you believe the denying official erred. Appeals must be

electronically transmitted or postmarked within 90 days of the date of the response to your request. Due to OPM's current maximum telework operations, it is recommended that FOIA administrative appeals be submitted via email to avoid processing delays.

Hi Jeremy,

The Pay and Leave team provided a rough estimate of the holiday paid time off benefit for 1 holiday as \$765 million (it represents the salaries paid for not working), and holiday premium pay costs is \$47 million for a single holiday in 2021. Some employees will work on the holiday.

These estimates do not include utility cost savings and are only for employees in the OPM EHRI-SDM database.

Attached please find the text of S. 475, the Juneteenth National Independence Day Act, which passed the Senate on June 15, 2021. 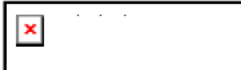

Good Afternoon -

Late yesterday the White House confirmed that the President will sign the Juneteenth National Independence Day Act, establishing June 19th as a federal holiday, this afternoon. As June 19th falls on a Saturday, the holiday will be recognized by the federal government tomorrow, Friday, June 18th, for most federal employees. OPM is finalizing implementation guidance to federal agencies and will have more information to share in the coming hours.

Previously Scheduled Leave

- An employee who was previously scheduled to take annual leave on June 18, 2021 will not be charged annual leave (or any other form of paid leave, compensatory time off, or credit hours).
- The 002 Holiday Observed Time Reporting Code (TRC) will be automatically reflected on timesheets for anyone who has not already saved or submitted time for this pay period, even if an absence request was previously submitted for 06/18. If an employee has already saved or submitted their timesheet for this pay period, those timesheets must be manually adjusted by the employee, supervisor, or time admin to report the holiday. If you experience any issues, please contact your organization's timekeeper.

Timekeeping Implications

- Employees on a Flexible AWS schedule: Full-time employees on a flexible work schedule are entitled to 8 hours of pay on a holiday. Due to the unique nature of this situation, full-time employees on a flexible AWS schedule who work 9 hour and 10 hour days are authorized to use administrative leave to account for 1-2 hours for pay period ending 06/19/2021.
- "In lieu of" holiday: When a holiday falls on a non-workday outside a full-time employee's basic workweek, the employee is entitled to an "in-lieu-of" holiday. The general rule is that the "in-lieu-of" holiday is the workday immediately preceding the non-workday. If the employee has a regularly scheduled workday on Thursday, June 17 and a regularly scheduled non-workday on Friday, June 18, Thursday, June 17 becomes the "in lieu of" holiday for June 18.
For those employees whose in lieu of holiday would be today, they will:
 - receive holiday premium pay for the hours worked today (not to exceed 8 hours, use Time Reporting Code: 011 – Holiday Worked),
 - can also end their workday immediately (if applicable); and
 - receive holiday pay for the remainder of their workday (if applicable, used Time Reporting Code: 002 – Holiday Observed). Please notify your supervisor if you opt to end your workday early.
- Part-time employees under a flexible work schedule are generally excused from duty for the number of hours of his or her basic work requirement.

- Employees on a Compressed AWS schedule (i.e., FSEM Sitroom Operations): A full-time or part time employee on a compressed work schedule is entitled to the number of hours they were scheduled to work on the holiday. For example, if a holiday falls on a 10-hour basic workday, the employee's holiday is 10 hours.





This Saturday, June 19, 2021, America celebrates the 155th anniversary of the Juneteenth (short for “June Nineteenth”) celebration that occurred June 19, 1865, in Galveston, TX, when federal troops arrived to take control of the state and announced that all enslaved people were free. Slavery had continued relatively unabated in Texas even though President Abraham Lincoln had signed the Emancipation Proclamation two and a half years earlier.

Today President Biden will sign into law the Juneteenth National Independence Day Act, establishing June 19th as a federal holiday. And on Saturday, the Biden-Harris administration will formally commemorate Juneteenth and call on the nation to reflect on the shameful and enduring legacy of slavery in this country.

As June 19th falls on a Saturday this year, the federal government will observe the holiday **tomorrow, Friday, June 18th**. This means that tomorrow will be treated as a federal holiday. Our OPM HR team is working hard to prepare and distribute guidance for this holiday, so be on the lookout for that later today.


