This is the final response to your December 26, 2020 Freedom of Information Act (FOIA) request to the U.S. Agency for International Development (USAID). You requested a copy of the listing of USAID Office of Inspector General Investigations closed during Calendar Year 2020. (Date Range for Record Search: From January 1, 2020 To December 26, 2020)

For your information, Congress excluded three (3) discrete categories of law enforcement and national security records from the FOIA. See 5 U.S.C. § 552(c) (2006 & Supp. IV (2010)). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all of our requesters and should not be construed as an indication that excluded records do, or do not, exist.

USAID conducted a comprehensive search of the Office of the Inspector General (IG) for documents responsive to your request. The search produced a total of [2] pages. Of those pages, we have determined that [2] pages of the records are releasable in their entirety, pursuant to Title 5 U.S.C. § 552.
