This letter is in response to your Freedom of Information Act (FOIA), Title 5, United States Code, Section 552, request submitted October 12, 2021, to the U.S. Census Bureau's FOIA Office. We received your request in this office on October 12, 2021. We have assigned to it tracking number DOC-CEN-2022-000060 and are responding under the FOIA to your request for a copy of the Census Bureau's Congressional Correspondence Log(s) for the years 2017 through 2021.

Enclosed are three (3) records (93 pages) that are responsive to your request with withholding determinations noted. We withheld portions of the documents pursuant to FOIA Exemption 6, Title 5, United States Code, Section 552(b)(6). Exemption 6 protects from disclosure information about individuals, the release of which would constitute a clearly unwarranted invasion of personal privacy.

Based on the above information, this constitutes a partial denial of your request. You have the right to appeal this partial denial of the FOIA request. An appeal must be received within 90 calendar days of the date of this response letter. Address your appeal to the following office:

The appeal should include a copy of the original request and initial denial, if any. All appeals should include a statement of the reasons why the records requested should be made available and why the adverse determination was in error. The appeal letter, the envelope and the e-mail subject line should be clearly marked "Freedom of Information Act Appeal."

The e-mail and FOIAonline are monitored only on working days during normal business hours (8:30 a.m. to 5:00 p.m., Eastern Time, Monday through Friday). FOIA appeals posted to

the e-mail box or FOIAonline after normal business hours will be deemed received on the next normal business day. If the 90th calendar day for submitting an appeal falls on a Saturday, Sunday or legal public holiday, an appeal received by 5:00 p.m., Eastern Time, the next business day will be deemed timely.
