This is the final response to your Freedom of Information Act (FOIA) request, originally received by the United States Secret Service (Secret Service) on February 10, 2021, for each email in the email accounts of the following person in the US Secret Service, Office of Government and Public Affairs (the Deputy Assistant Director for Congressional Affairs), which contains any of the following words: capital, capitol, police, attack, mob, violence or Trump. You also requested to limit this request to emails on January 6 and January 7, 2021 to include; to, from and cc: emails.

After a detailed review of all potentially responsive records, 91 pages were released and eight (8) pages were withheld in their entirety. Exemptions under the FOIA Statute, Title 5 U.S.C. § 552 have been applied where deemed appropriate.

Enclosed are the documents responsive to your request, as well as a document that explains the exemptions in more detail. Withheld information is pursuant to the exemptions marked below.
