FREEDOM OF INFORMATION ACT REQUEST ORO-2021-00286-F

This letter and the enclosure complete our response to your December 19, 2020, Freedom of Information Act (FOIA) request you submitted to the U.S. Department of Energy (DOE) Office of Science Consolidated Service Center (OSCSC) - Oak Ridge location for "a copy of each video or film about ITER at the US ITER Office. You may limit this request to videos or films between 1980 and present. You may limit this search to records accessible in the US ITER Office."

In an e-mail dated September 3, 2021, you agreed to narrow your request to a list of all videos, within the last 10 years, at the US ITER Office. The enclosed list consists of all the videos at the US ITER Office located at the Oak Ridge National Laboratory. The list covers the timeframe of 2009-2021.

This decision, as well as the adequacy of the search, may be appealed within 90 calendar days from your receipt of this letter pursuant to 10 C.F.R. § 1004.8. Appeals should be addressed to: Director, Office of Hearings and Appeals, U.S. Department of Energy, L'Enfant Plaza, 1000 Independence Avenue, S.W., Washington, D.C. 20585-1615. The written appeal, including the envelope, must clearly indicate that a FOIA appeal is being made. You may also submit your appeal by e-mail to OHA.filings@hq.doe.gov, including the phrase "Freedom of Information Appeal" in the subject line (this is the method preferred by the Office of Hearings and Appeals). The appeal must contain all the elements required by 10 C.F.R. § 1004.8, including a copy of this determination letter. Thereafter, judicial review will be available to you in the Federal District Court either: (1) in the district where you reside; (2) where you have your principal place of business; (3) where DOE's records are situated; or (4) in the District of Columbia. You may contact the DOE Oak Ridge FOIA Public Liaison, Ms. DiAnn Fields-Gilbert at (865) 574-3612 or by writing to the address on the top of this letter for further assistance and to discuss any aspect of your request.
