On **03/28/2022** we received your request under the Freedom of Information Act for access to:

**A copy of the FOIA Case Log (List of FOIA requests received by FMCS) during calendar years 2018, 2019, 2020 and 2021, but including the field "summary of request" which was present in the posted FOIA case logs until 2017, after which it has been omitted. I request these records because I understand that the FMCS FOIA Office maintains the records that include the "summary of request" column/field. I tried to upload a copy of the 2017 FOIA Log in this system as an example but the FOIA.gov site prohibits uploading of an Excel file format.**

In accordance with the FOIA and agency policy, we have searched our records. This is a partial grant of your request. Portions of the records are redacted under the exemptions as explained below.

Some records contain personally identifiable information. This information is exempt from release under FOIA Exemption 6, 5 U.S.C. §(b)(6), because individuals' right to privacy outweighs the general public's interest in seeing personal identifying information. *See The Lakin Law Firm v. FTC*, 352 F.3d 1122 (7<sup>th</sup> Cir. 2003).

Your request did indicate an agreement to pay any fees associated with the processing of your request. However, the Agency's fee regulations specify that fees less than \$25 will be waived. *See 29 C.F.R. § 1401.36*. Because the fees associated with the processing of your request did not exceed \$25, we have processed your request free of charge.
