Re: Final Determination Letter FOIA Case 23-009

I am responding to your request dated and received October 15, 2022, by the FOIA Office of the Indian Health Service (IHS). You requested the following:

"The cover page and title page of each IHS "Quality Assurance Review" during the time period January 1, 2017 to the present, limited to a search of IHS HQ. I also request a copy of each listing of Quality Assurance Reviews at IHS HQ."

Your request was processed pursuant to the FOIA and HHS regulations. At this time, we are providing approximately 1 page of material to you in its entirety. The responsive document is titled, "List of reports for IHS Quality Assurance" and contains a list of quality assurance reports (requested item 2).

Additionally, these quality assurance reports do not contain a "cover page and title page" as requested in item 1 of your request and therefore are not available for disclosure. This is a no records exist response for requested item 1.

As this constitutes a partial denial of your request for agency records, I am providing you your appeal rights. By filing an appeal, you preserve your rights under FOIA and give the agency a chance to review and reconsider your request and the agency's decision. Your appeal must be electronically transmitted within 90 calendar days of the date of this letter, to
