Re: Freedom of Information Act Request No. F-2021-00111

This is in response to your correspondence dated January 10, 2021, and received by the Board's Information Disclosure Section on January 22. Pursuant to the Freedom of Information Act ("FOIA"), 5 U.S.C. § 552, you seek:

(1) A copy of the title page/cover page for the NIC Processing Instruction Guide[; and]

(2) A copy of the table of [contents] for the NIC Processing Instruction Guide.

With respect to item 1 of your request, staff searched Board records and consulted with knowledgeable staff but did not locate a "title page/cover page" that is responsive to your request.

With respect to item 2 of your request, staff searched Board records and consulted with knowledgeable staff but did not locate a table of contents that is responsive to this part of your request. However, by utilizing other sources of information related to the NIC Processing Instruction Guide, staff was able to create a table of contents that is responsive to item 2 of your request. While the FOIA generally does not require the creation of records, this table of contents will be provided to you by the Board's Information Disclosure Section under separate cover.

Your request for information is, therefore, granted in part and denied in part for the reasons cited above. If you believe the determination that no responsive records exist for item 1 is incorrect, you may administratively appeal by writing to Office of the Secretary, Board of Governors of the Federal Reserve System, Attn: FOIA Appeals, 20th Street & Constitution Avenue NW, Washington, DC 20551; by facsimile to 202-872-7565; or electronically to FOIA-Appeals@frb.gov. Your appeal must be postmarked or electronically transmitted within 90 days of the date of the response to your request.¹
