Subject: Response to Freedom of Information Act (FOIA) Request DOI-NPS-2023-000392

This letter is in response to your Freedom of Information Act (FOIA) request dated October 24, 2022, in which you requested:

I request records identifying the 21 previously authorized studies for potential units of the National Park System, potential new national heritage areas, and potential additions to the National Trails System and National Wild and Scenic Rivers System that have not yet been completed and transmitted to Congress. National Parks Service Associate Director for Park Planning, Facilities, and Lands Mike Caldwell mentioned these studies in his testimony before the Senate Energy and Natural Resources National Parks Subcommittee on Sept. 21, 2022.

Upon review, your request has been granted in full. Attached is one PDF consisting of 3 pages. In the time since Associate Director Caldwell testified regarding the 21 previously authorized studies, two studies have been completed and transmitted to Congress: The Amache Special Resource Study (sent to Congress on October 13, 2022), and the Cold War Defensive Sites National Historic Landmarks Theme Study Transmittal (sent to Congress November 7, 2022).

We have conducted a foreseeable harm analysis under the FOIA Improvement Act of 2016 and, after consulting with a subject matter expert, 1) we do not reasonably foresee that disclosure of this information would harm an interest that the FOIA's exemptions were designed to protect and 2) disclosure would not be prohibited by law. Therefore, we are releasing this information in full. Please be aware that our decision to release this information does not mean that we have waived our ability to invoke applicable FOIA exemptions for similar or related information in the future.

Appeals arriving or delivered after 5 p.m. Eastern Time, Monday through Friday, will be deemed received on the next workday. See <u>43 C.F.R. § 2.57, .58</u>

<u>Your appeal must be made in writing</u>. You may submit your appeal and accompanying materials to the FOIA/Privacy Act Appeals Officer by mail, courier service, fax, or email. *Key to Study Terms

Special Resource Study (SRS) - Congressionally authorized study to determine if an area meets the criteria to be recommended as a new unit of the national park system (national significance, suitability, Reconnaissance Survey - A preliminary assessment of whether or not a resource/area is a good candidate for a full special resource study; by law may not exceed \$25,000. In addition, they have been undertaken for other types of national designations such as Wild & Scenic Rivers, National Historic Trails, and Affiliated Areas. A reconnaissance survey offers indications of whether the resource/area is **National Heritage Area (NHA) Feasibility Study** - Evaluation to determine an area's suitability and feasibility to be eligible for designation as an NHA.
