Below is the Smithsonian's response to your request for records dated April 16, 2011.[1 – see below] You asked for a copy of "the public records request case log/list for the Smithsonian for the time period January 1, 2009 to the present."

Attached you will find a list of requests that the Office of General Counsel (OGC) received for the time period of January 1, 2009 to present. The attached list is labeled SI-000001 – SI-00010. Please note that some entries do not identify the name of the requester. In these requests, the requester asked for records related to themselves, and so their names have been withheld for privacy reasons. The *U.S. Department of Justice Guide to the Freedom of Information Act* states on pp. 429 – 430 that "FOIA requesters (except those making requests for records on themselves) do not ordinarily

expect that their names will be kept private; therefore, release of their names would not cause even the minimal invasion of privacy [...]” [emphasis added].

This list contains all of the records requests that OGC received for the time period you requested. However, the Smithsonian’s Office of the Inspector General (OIG) maintains its own records requests separate from OGC. If you would like to receive a listing of OIG’s records requests for this time period, please make a separate request to OIG.
