Pursuant to the Freedom of Information Act (FOIA), you requested copies of "the entire last three pages of records (the Appeals list) that was considered responsive in part in a previous request F10-0117", and "this type of Appeals list for as large a span a time period as can be provided".

Your request was processed in accordance with the Freedom of Information Act, 5 U.S.C. § 552, as amended. A thorough search of our files and databases located one record consisting of three pages responsive to your request. This record represents the available Appeals list in its entirety, and is being released to you in full.

The FOIA authorizes federal agencies to assess fees for record services. Based upon the information provided, you have been placed in the "other" category of requesters, which means you are responsible for search fees exceeding two hours and duplication fees (.15 per page) exceeding 100 pages. In this case, no assessable fees were incurred.
