This responds to your January 29, 2010, Freedom of Information Act (FOIA) appeal.

A review of the denied information has been completed at the appellate level and I have determined that more information may now be released from the enclosed document. Some of the redacted information within this document remains exempt from release because it applies solely to Department of Defense (DoD) internal rules and practices, which if released, would risk circumvention of the DoD mission. Some information remains exempt from release because it is pre-decisional and deliberative in nature and contains subjective evaluations, opinions, and recommendations that could inhibit decision making processes. Additionally, this document contains privileged communications between an attorney and a client for the purpose of securing legal advice. Release of this information would have the foreseeable harm of curtailing frank discussions and recommendations in the future. Finally, some of the redacted information is withheld because release would constitute a clearly unwarranted invasion of the personal privacy of individuals. Consequently, I must deny this information pursuant to 5 U.S.C. § 552 (b)(2)(High), (b)(5), and (b)(6).

You have the right to judicial review of this decision in a United States District Court in accordance with 5 U.S.C. § 552(a)(4)(B).
