Section 111 of Title I, Division J, of the Fiscal Year 2005 Consolidated Appropriations Act (Public Law 108-447) was enacted on Dec. 8, 2004, and requires the head of each Federal agency to provide each new employee of the agency with educational and training materials concerning the U.S. Constitution as part of the orientation materials provided to the new employee; and to provide educational and training materials concerning the U.S. Constitution to each employee of the agency each year.
