This letter is in final response to a Freedom of Information Act (henceforth "FOIA")¹ request submitted to the Office of Science and Technology Policy (hereinafter "OSTP") on May 1, 2023. The request specifically sought:

• "A copy of each list of subcommittees of the NATIONAL SCIENCE AND TECHNOLOGY COUNCIL (NSTC)."

Upon receipt of the request, OSTP performed a search of its files and located one record totaling 8 pages that is being released in full.

Accordingly, this completes the processing of this request. OSTP now considers this matter closed.

In accordance with the FOIA and OSTP regulations, a requestor may appeal an agency's decision.² Any appeal related to the processing of this request must be sent either (1) via email to <u>OSTPFOIA@ostp.eop.gov</u>; or (2) by mail to Chief FOIA Officer, Office of Science and Technology Policy, Eisenhower Executive Office Building, 1650 Pennsylvania Avenue, NW, Washington, D.C 20504.³ In the appeal letter, please specify OSTP-FOIA Control #: **23-028**. Any appeal must be sent to one of the above listed addresses no later than ninety (90) calendar days after the date of this letter."⁴






Committee on Science






Committee on STEM Education







Committee on Environment






