This is the final response to your Freedom of Information Act (FOIA) request, originally received by the United States Secret Service (Secret Service) on October 17, 2022, for information pertaining to a copy of memos, reports, analysis, written discussions, emails or other records at the Secret Service concerning the rates charged to the Secret Service by The Trump Organization for hotel lodging or rooms to support presidential protection, from January 21, 2021 to the present.

After a detailed review of all potentially responsive records, 44 page(s) were released and 0 page(s) were withheld in their entirety. After considering the "Foreseeable Harm" standard, outlined in Title 5 U.S.C § 552(a)(8)(A)(i) and Department of Justice guidance, exemptions under FOIA Statute Title 5 U.S.C. § 552, and/or the PA Statute Title 5 U.S.C. § 552a, have been applied where deemed appropriate.

Enclosed are the documents responsive to your request, as well as a document that explains the exemptions in more detail. Withheld information is pursuant to the exemptions marked below.

Dear Director Murray:

I am writing to follow up on the Committee's previous request for Secret Service records on spending at properties owned, controlled, or branded by former President Donald Trump and his businesses. On February 12, 2020, the Committee requested documents concerning taxpayer-funded spending at former President Trump's properties by the Secret Service after reports emerged that President Trump's company charged the Secret Service nightly room rates as high as \$650 to stay at Trump properties and \$17,000 per month for Secret Service to stay in a three-bedroom cottage at Trump National Golf Club Bedminster.¹ The Secret Service's failure to timely report expenditures to Congress—as required by law under the Presidential Protection Assistance Act of 1976—compounded the Committee's concerns.²

The Committee requested production of three categories of documents by February 25, 2020.³ Although the Secret Service provided some information in response to the Committee's request, the Service failed to produce any of the requested documents.⁴ To this day, Secret Service has not produced core documents requested by the Committee, which the Committee needs to gain a complete understanding of the agency's spending.

Recent reports indicate that, even after leaving office, former President Trump continues to charge the Secret Service high room rates for the agents who stay at his properties as part of the security detail he receives as a former president. According to press reports, spending records show that the former president has charged the Secret Service \$396.15 per room at his resort in Mar-a-Lago every night starting January 20, 2021, the day Mr. Trump left office.⁵ This nightly rate is well beyond the government employee spending limit of \$205 per night in Palm Beach County.⁶ Since January 2021, American taxpayers have footed more than \$50,000 in hotel bills at Mr. Trump's properties, including more than \$10,000 paid to Trump National Golf Club Bedminster in the month of May alone.⁷

As I have previously explained, the Committee does not seek specific information about protective operations or any other sensitive information relating to the security of former President Donald Trump.⁸ However, the Committee has a compelling legislative interest in information concerning the expenditure of government funds made or reimbursed by the Secret Service at properties owned, controlled, or branded by the Trump Organization. Information on how and why the Secret Service has incurred exorbitant expenses at former President Trump's properties both during and after his presidency is critical for the Committee to ensure that taxpayer dollars are being used appropriately and responsibly and to determine whether legislative reform is needed to prevent presidential self-dealing.

For these reasons, the Committee requests that you produce the following documents by September 29, 2021. The time period for these requests is from January 20, 2017, to the present.

- 1. All documents or communications between the Secret Service and the Trump Organization, or any subsidiary or affiliate of the Trump Organization, referring or relating to the estimated or actual expenditures by the Secret Service for any rental of rooms or other accommodations at properties owned, controlled, or branded by the Trump Organization;
- 2. All documents referring or relating to the expenditure of government funds made or reimbursed by the Secret Service to provide security or any other services for former President Donald Trump, or his family members, during and after his

> presidency, at properties owned, controlled, or branded by the Trump Organization, including but not limited to reports in the Financial Repository for Enterprise Data;

- 3. All contracts, purchase orders, and invoices between the Secret Service and the Trump Organization referring or relating to the rental of rooms or other accommodations at properties owned, controlled, or branded by the Trump Organization; and
- 4. All internal documents, communications, memoranda, or analyses related to the Secret Service's decision to pay the Trump Organization or properties owned, controlled, or branded by the Trump Organization above the government employee *per diem* spending limit for lodging.

The Committee on Oversight and Reform is the principal oversight committee of the House of Representatives and had broad authority to investigate "any matter" at "any time" under House Rule X. In addition, House Rule X, clause 3(i) specifically charges the Committee with conducting oversight of "the operation of Government activities at all levels, including the Executive Office of the President."

Dear Director Cheatle:

For several years, the Committee has been investigating former President Donald Trump's attempts to personally profit off his presidency, including by charging the Secret Service exorbitant rates when protecting the President and members of his family at Trump Organization properties. Despite claims by the Trump Organization that federal employees traveling with the former President would stay at Trump properties "for free" or "at cost," new information obtained by the Committee shows that the former President's company charged the Secret Service excessive nightly rates on dozens of trips. These rates were as high as \$1,185 per room per night, more than five times the government rate. The exorbitant rates charged to the Secret Service and agents' frequent stays at Trump-owned properties raise significant concerns about the former President's self-dealing and may have resulted in a taxpayer-funded windfall for former President Trump's struggling businesses.¹

The Committee has been seeking a full accounting of the Secret Service's expenditures at Trump Organization properties for more than two years but still has not received complete information on nightly rates or the total amount the Secret Service paid to the Trump Organization—which appears to exceed \$1.4 million in taxpayer dollars. The materials the Secret Service has provided raise significant concerns about the agency's spending at Trumpowned properties, including exorbitant rates, incomplete documentation, and invoices that do not appear to match agency financial records.

The Committee's Investigation of Secret Service Spending

During his term, former President Trump reportedly visited his properties 547 times including 145 visits to his Mar-a-Lago Club in Palm Beach, Florida—while retaining his ownership interests in the properties.² Because the Secret Service is required by law to protect the First Family, when President Trump or his family members stayed at a Trump-owned property, the Secret Service typically purchased rooms and other services at these properties. The former President's stays at certain properties were so frequent, they required the Secret Service to establish a more enduring presence.³ The Secret Service also stayed at Trump properties while protecting other individuals, including foreign leaders. Whenever the Secret Service purchased hotel rooms at these properties, the Trump Organization—and its owner, Donald Trump—were paid using taxpayer funds.

Like other federal agencies, the Secret Service follows the government-wide Federal Travel Regulation (FTR), which is managed by the General Services Administration (GSA) and governs travel by federal employees. Under the FTR, agencies generally keep lodging costs at or below the rates set by GSA—commonly called "government rates" or "per diem rates"—which are based on the average daily rate of hotel properties by location and time of year.⁴ Rates that are higher than the government rate are generally subject to additional agency scrutiny and a limit for reimbursement.⁵ Beginning in 2017, the Secret Service received authorization for additional flexibility for expenses during protective missions, including per diem expenses above the government rate.⁶

On February 12, 2020, following reports that former President Trump's hotels, resorts, and private clubs were charging the Secret Service exorbitant rates as part of the agency's mission to protect the President and his family, the Committee requested documents concerning taxpayer-funded spending at Trump properties.⁷

On September 15, 2021, the Committee sent a second letter reiterating our requests and highlighting reports that the Trump Organization continued to charge the Secret Service excessive rates to protect former President Trump at his hotels, resorts, and clubs after former President Trump left office. In that letter, I explained the goal of the Committee's investigation:

[The] Committee has a compelling legislative interest in information concerning the expenditure of government funds made or reimbursed by the Secret Service at properties owned, controlled, or branded by the Trump Organization. Information on how and why the Secret Service has incurred exorbitant expenses at former President Trump's properties both during and after his presidency is critical for the Committee to ensure that taxpayer dollars are being used appropriately and responsibly and to determine whether legislative reform is needed to prevent presidential self-dealing.⁸

New Evidence of Excessive Rates at Trump Properties

In response to concerns that the Trump Organization was profiting off the presidency, company officials publicly stated that they only charged minimal fees when government officials traveling with President Trump stayed at Trump-owned properties.⁹ In 2019, Eric Trump, the Trump Organization's Executive Vice President stated:

If my father travels, they stay at our properties for free. So everywhere that he goes, if he stays at one of his places, the government actually spends, meaning it saves a fortune because if they were to go to a hotel across the street, they'd be charging them \$500 a night, whereas, you know we charge them, like \$50.¹⁰

In February 2020, Eric Trump claimed, regarding lodging for Secret Service: "We provide the rooms at cost and could make far more money renting them to members or guests."¹¹

However, documents obtained by the Committee call these statements into question. As part of its investigation, the Committee obtained records from the Secret Service reflecting the

agency's spending at Trump-owned properties in the United States from January 20, 2017, through September 15, 2021. These documents indicate that the Trump Organization charged the Secret Service a nightly rate in excess of the government per diem rate **at least 40 times** from the beginning of the Trump Administration through September 15, 2021.¹² In several instances, the rates charged were more than three times the per diem rate.¹³

Records show the Secret Service spent more than \$1.4 million on lodging at Trumpowned properties in the United States from January 20, 2017, through September 15, 2021.¹⁴ As described below, this figure does not appear to account for all Secret Service payments to Trump properties, and the Committee is continuing to seek a full accounting of this spending.¹⁵

The Committee has also obtained documentation of specific instances in which the Secret Service was charged excessive rates to stay at Trump Organization properties, including the Trump International Hotel in Washington, D.C., and the Mar-a-Lago Club in Florida.

Documents indicate that in March 2017 the Trump Organization charged the Secret Service a nightly room rate of \$1,160 for a stay at the Trump International Hotel in Washington, D.C.—nearly five times the government rate at the time—as part of the Secret Service's legal obligation to provide security for Eric Trump.¹⁶ At the time, Eric Trump was visiting Washington, D.C., to promote an upcoming golf tournament at the nearby Trump National Golf

Club. During his stay, Eric Trump bragged that the "stars have all aligned" for the Trump Organization and said the Trump "brand is the hottest it has ever been."¹⁷ As the Committee later learned, the Trump International Hotel in Washington, D.C., was actually losing millions of dollars and would go on to lose over \$70 million during former President Trump's term in office.¹⁸

On numerous other occasions when Eric Trump or his wife Lara Trump chose to stay at the Trump International Hotel in Washington, D.C., Secret Service records indicate that the agency was charged rates well in excess of the per diem rate, including five stays with rates at approximately triple the government rate.¹⁹

In November 2017, when Donald Trump, Jr., stayed at the Trump International Hotel in Washington, D.C., Secret Service records indicate that the hotel charged the agency a rate of (b)(7)(E) per room per night—almost six times the government rate at the time.²⁰

In addition, records show that on at least six occasions when former President Trump stayed at his Mar-a-Lago Club, the property charged his Secret Service detail nightly rates that were nearly double the government per diem rate, including a nearly month-long stay where "The government rate could not be negotiated for this purpose," according to Secret Service records.²¹

Due to the nature of its protective mission, Secret Service agents occasionally stay at locations where the lodging rate is above the GSA per diem rate. However, field offices are required to file a "GSA variance request" and obtain approval from the Secret Service to pay rates above the per diem maximum.²² Generally, the maximum reimbursement authorized for federal civilian employees is 300% of the GSA per diem rate, although the Secret Service may exceed this for employees on protective missions.²³

The Committee has obtained at least 40 approved "Requests for GSA Lodging Variance" in which the Secret Service approved the payment of nightly rates above the per diem rate at

Trump-owned properties.²⁴ The Secret Service has informed the Committee staff that it was unable to locate variance requests for additional instances in which agency records show that the agency may have paid a rate above the per diem rate.

Missing and Incomplete Records of Expenditures at Trump Properties

The Secret Service still has not provided the Committee a full accounting of the agency's expenditures at Trump properties. In particular, the Secret Service has not provided documents sufficient to determine each instance when a Trump-owned property charged the Secret Service more than the government per diem rate. The Secret Service also has not provided the Committee with complete nightly rate information for all the agency's stays at Trump-owned properties, which would include hundreds of visits. As a result, the Committee is unable to determine the full amount of taxpayer money the Secret Service spent at properties owned by the former President.

The records of spending at Trump Organization properties provided by the Secret Service list 669 expenditures, totaling \$1.4 million.²⁵ However, as previously mentioned, the records do not appear to be complete. For example, a 2019 Government Accountability Office report evaluated the cost of four presidential trips to Mar-a-Lago and found that Secret Service booked "a limited number of rooms" at Mar-a-Lago on each of these four trips. The spending records provided to the Committee by the Secret Service do not appear to include expenditures at Mar-a-Lago during the time period of these trips.²⁶ In addition, the data obtained by the Committee does not include any Secret Service payments to Trump properties outside the United States during the extensive foreign travel by former President and his family.

Other documents obtained by the Committee also suggest the spending records provided may be incomplete. For example, the Secret Service provided multiple invoices for stays at the Trump National Golf Club in Bedminster, New Jersey, each for \$17,565.84, which do not appear to be reflected on the agency's spending records.²⁷ Accommodation agreements with the Mar-

A-Lago Club for amounts ranging between \$4,753.80 and \$11,884.50 also do not appear to be reflected in the records.²⁸

Committee Requests

Given the longstanding concerns surrounding the former President's conflicts of interest and efforts to profit off the presidency, the Committee has a strong interest in obtaining a complete accounting of federal government spending at Trump properties. The Committee continues to examine potential legislation to prevent presidential self-dealing and profiteering, as well as to curb conflicts of interest by ensuring that future presidents are prevented from exercising undue influence on Secret Service spending.

For these reasons, the Committee requests that you produce by October 31, 2022, the following information and documents for the time period of January 20, 2017, to present. Please note that this information is also responsive to the Committee's September 15, 2021, requests:

- 1. Identify all Secret Service stays at properties owned, controlled, or branded by the Trump Organization;
- 2. Identify the total amount paid by the Secret Service for each stay responsive to Request 1;
- 3. Identify the nightly rate paid by the Secret Service for each stay responsive to Request 1;
- 4. Provide all internal documents, communications, memoranda, or analyses, including all Requests for GSA Lodging Variance, related to Secret Service payments of nightly rates in excess of the government employee per diem rate for any stay responsive to Request 1; and
- 5. Identify and explain any stays responsive to Request 1 in which the Secret Service paid a nightly rate in excess of the government employee per diem rate but for which no Request for a GSA Lodging Variance has been identified.

The Committee on Oversight and Reform is the principal oversight committee of the House of Representatives and has broad authority to investigate "any matter" at "any time" under House Rule X.
