This letter responds to your appeal, received on January 12, 2023, of the referenced Department of Veterans Affairs (VA) Office of the Inspector General (OIG) FOIA response. As background, on December 20, 2022, the VA OIG received a FOIA request from you, via the National FOIA portal, requesting "a copy of the listing of Office of Inspector General investigations (not audits) closed during calendar years 2021 and 2022, to include fields such as the case number, the date the investigation was closed, the title or subject of the investigation, the category or type of investigation, etc." The OIG FOIA staff sent a final response on January 12, 2023, with a redacted excel spreadsheet containing the specific columns you requested. The OIG FOIA staff had to create this record to respond to your request. The response letter explained that the redacted information was withheld under FOIA Exemptions 3, 6, 7(C), 7(D) and 7(E). On January 12, 2023, the VA OIG received your appeal of the final response where you "appeal the withholding of the case (MCI) number for each case" and "appeal the withholding of the 'open date' for each case." As the VA OIG FOIA appeal authority, I reviewed the file for response #23-00014-FOIA, the appeal correspondence, and relevant caselaw.

In response to your appeal of "the withholding of the case (MCI) number for each case," after a review I determined to remand the excel file for the release of the case numbers. This letter documents the agency's decision on this portion of your appeal to remand the excel file to the VA OIG initial denial authority, directing that authority to disclose the case number for each case. You should receive a response from the VA OIG FOIA staff in a reasonable period of time. In response to your appeal of "the withholding of the 'open date' for each case," I determined that you did not request the open date for each case in your FOIA request and omitting that data was not an error.¹ Therefore, I find that the FOIA

response was proper, and this portion of your appeal is denied. If you intend to file a new request, you can submit it directly to the VA OIG FOIA staff, via email at: VAOIGFOIA-PA@va.gov, as described at: <https://www.va.gov/oig/foia/>, or via the VA Central Office FOIA Service or the National FOIA portal.

This is the final decision of the Department of Veterans Affairs on your appeal. The FOIA requires that I advise that, if you believe the Department erred in this decision, you have the right to file a complaint with the appropriate United States District Court. The FOIA also requires I advise that FOIA requesters may contact the Office of Government Information Services (OGIS) at the National Archives and Records Administration to inquire about the FOIA mediation services they offer as non-exclusive alternatives to litigation.
