





This is an interim response to your FOIA Request Number 2021-005458, dated June 16, 2021, seeking copies of reports of unruly passenger behavior dating back to January 5, 2021 through January 25, 2021. Your request was assigned to the Office of Security and Hazardous Materials Safety.

Based on the information you provided, we located records held by our Washington Operations Center that are responsive to your request. The records contain information that originated with other agencies, including the Transportation Security Administration (TSA), with which we have consulted before our response. TSA has provided 24 pages of responsive records dated January 1, 2021 to January 25, 2021. The records contain information that has been determined to be exempt from disclosure under 5 U.S.C. § 552, specifically Exemption (b)(3). 49 U.S.C. § 114 exempts Sensitive Security Information, the disclosure of which would be detrimental to security of transportation.

The envelope containing a mailed appeal or the subject line of an electronic appeal should be prominently marked "FOIA Appeal."
