This responds to your request dated October 12, 2023, to Interpol Washington, U.S. National Central Bureau (USNCB), pursuant to the Freedom of Information Act (FOIA) for information concerning a copy of the Interpol-National Central Bureau FOIA Logs for FY2021, FY2022, and FY2023.

We received your request on October 13, 2023. Please refer to the above FOIA number assigned to your request in any additional correspondence. The USNCB has adopted a "multi-track processing" of FOIA requests based on the estimated amount of work and time needed to process the request. The criteria for assignment to a specific track can be found in the Department of Justice FOIA Regulations at 28 C.F.R. § 16.5(b). Your request has been assigned to the simple track.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. *See* 5 U.S.C. § 552(c). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist. Please be advised that we have considered the foreseeable harm standard when reviewing records and applying FOIA exemptions.

A reasonable search of the INTERPOL Washington indices located materials responsive to your request. We are releasing 54 pages with partial redactions pursuant to Title 5, United States Code, Section 552 (b)(6) of the FOIA. Please be advised that we have considered the foreseeable harm standard when reviewing records and applying FOIA exemptions.


Exemption (b)(6) concerns material the release of which would constitute a clearly unwarranted invasion of personal privacy of third parties.

Your appeal must be postmarked or electronically transmitted within 90 days of the date of my response to your request. If you submit your appeal by mail, both the letter and the envelope should be clearly marked "Freedom of Information Act Appeal."
