Re: FOIA request for specified records from the Access Board's ABA complaint tracking system (#2021-08)

This letter responds to your Freedom of Information Act (FOIA) request to the U.S. Access Board (Access Board), received via email on July 13, 2021 and modified on July 20, 2021, seeking "records of ABA complaints readily retrievable from [the Access Board's] complaint tracking system including date filed, facility name, city and state of facility, date of closure, and type of closure."

Please find enclosed an excel spreadsheet containing the requested records, as well as three publicly available lists of complaints that were closed after corrective action during the past three fiscal years.

The closure codes in the spreadsheet have the following meanings:

- 5a-12 Corrective action
- 5b-12 No jurisdiction
- 5c-12 No violation
- 5d-12 No jurisdiction but corrective action taken

Access Board Resolves 43 Architectural Barriers Act Cases Through Corrective Action in FY 2018

November 05, 2018

The Access Board was created in part to enforce the first federal law to address accessibility, the [Architectural Barriers Act \(ABA\)](#). This law requires access to buildings or facilities that were designed, built, or altered with federal dollars or leased by federal agencies. The Board also maintains the guidelines upon which the ABA Standards are based.

With passage of other laws, including the landmark Americans with Disabilities Act (ADA), the Board's mission has expanded significantly. It is now responsible for developing and keeping up to date accessibility requirements for the wide array of facilities covered by the ADA, as well as for transportation vehicles and systems. It also issues standards for information and communication technology and for medical diagnostic equipment.

Despite these other duties, the Board continues the important work of enforcing the ABA. We do this through the investigation of complaints from the public. Filing a complaint with the Board is easy to do and can be done through an [online form](#). Complaints should include the name and address of the facility and a brief description of the access barriers or issues. Complaints can be filed anonymously.

The first step of an investigation is to determine whether the facility at issue is covered by the ABA. If so, the next step is to determine whether the facility meets the applicable accessibility standard. If the facility is not subject to the ABA or if it meets the appropriate accessibility standard, the Board will advise the complainant of its findings. Some facilities are not covered by the ABA but by other laws such as the ADA, which is enforced by other agencies and the courts.

If the facility does not meet the applicable standard, the Board will work with the responsible entities to develop a plan to bring the facility into compliance. Complaints are typically resolved

amicably with the responsible agencies or departments. Cases remain open until all necessary corrective action is completed. In FY 2018, the Board resolved 43 cases through corrective action.

ABA Cases Resolved Through Corrective Action

U.S. Postal Facilities

- **U.S. Post Office (Charleston, West Virginia):** The Postal Service installed a required van accessible customer parking space.
- **U.S. Post Office (Urbana, Illinois):** The Postal Service repaired a broken platform lift at the accessible customer entrance.
- **U.S. Post Office (Elberton, Georgia):** The Postal Service installed a required van accessible customer parking space.
- **U.S. Post Office (Charlottesville, Virginia):** The Postal Service repaired automatic doors at the customer entrance.
- **U.S. Post Office (Woodstock, Virginia):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) the force needed to manually open the doors.
- **U.S. Post Office (Boulder, Colorado):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) the force needed to manually open the doors.
- **U.S. Post Office (Canton, North Carolina):** The Postal Service made alterations to the curb ramp as well as the ramp to the customer entrance to bring those elements into compliance.
- **U.S. Post Office (Maryland Heights, Missouri):** The Postal Service installed a required van accessible customer parking space and made alterations to the curb ramp to bring it into compliance.
- **U.S. Post Office (Christiansburg, Virginia):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) the force needed to manually open the doors.
- **U.S. Post Office (Washington, DC):** The Postal Service took corrective action to repair the automatic customer entrance door.
- **U.S. Post Office (Heilwood, Pennsylvania):** The Postal Service took corrective action to repair the customer entrance stairs and handrail.
- **U.S. Postal Service Processing and Distribution Center and Vehicle Maintenance Facility (Brooklyn, New York):** In this facility used by Postal employees, the Postal Service took corrective action to install several new accessible parking spaces in two different parking lots and to repair damaged pavement along the accessible routes connecting the parking lots to the buildings.



- **U.S. Post Office (Naperville, Illinois):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) the force needed to manually open the doors.
- **U.S. Post Office (El Paso, Texas):** The Postal Service took corrective action to remove an obstacle that was impeding access to a curb ramp from the parking lot to the sidewalk.
- **U.S. Post Office (Lexington, Virginia):** The Postal Service took corrective action to: install a required van accessible parking space; repair the customer entrance doors; and adjust, repair, or replace the door closers on the customer entrance doors and interior vestibule doors to lessen (and bring into compliance) the force needed to manually open the doors.
- **U.S. Post Office (Equality, Illinois):** The Postal Service took corrective action to ensure that the accessible customer parking spaces were well-marked, level, sufficiently wide, and did not impede the required accessible route.
- **U.S. Post Office (Forest Grove, Oregon):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) the force needed to manually open the doors.
- **U.S. Post Office (Minneapolis, Minnesota):** The Postal Service installed a required van accessible customer parking space.
- **U.S. Post Office (Sidney, Ohio):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) the force needed to manually open the doors.
- **U.S. Post Office (Verdi, Nevada):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) the force needed to manually open the doors.
- **Robert T. Stafford U.S. Post Office and Courthouse (Rutland, Vermont):** The Postal Service, working in conjunction with the General Services Administration and local contractors, performed the following corrective actions: installed appropriate signage indicating the location of the accessible building entrance; replaced various door closers to lessen (and bring into compliance) the force needed to manually open the doors; enlarged the accessible entrance vestibule; demolished and rebuilt one set of exterior stairs as well as the accessible entrance ramp; made necessary enhancements to the existing accessible parking spaces; and converted two inaccessible restrooms into compliant, accessible, single-user toilet rooms.
- **U.S. Post Office (Pembroke, Massachusetts):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) the force needed to manually open the doors.
- **U.S. Post Office (Brookville, Ohio):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) the force needed to manually open the doors.

- **U.S. Post Office (Delmar, New York):** The Postal Service took corrective action to repair the customer elevator and add required directional signage.
- **U.S. Post Office (St. Johns, Arizona):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) both the closing speed of the doors and the force needed to manually open the doors.
- **U.S. Post Office (Manlius, New York):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) the force needed to manually open the doors.
- **U.S. Post Office (San Francisco, California):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) the force needed to manually open the doors.
- **U.S. Post Office (Everett, Washington):** The Postal Service took corrective action to repair the sink in the toilet room at the facility.
- **U.S. Post Office (Connersville, Indiana):** The Postal Service took corrective action to bring the ramp to the accessible customer entrance into compliance.
- **U.S. Post Office (New York, New York):** The Postal Service took corrective action with respect to the inaccessible second floor of this facility by reopening a previously closed customer service area on the accessible first floor of the building.

Military and Veterans Affairs Facilities

- **Gulf Coast Veterans Healthcare System (Biloxi, Mississippi):** The Department of Veterans Affairs installed additional required accessible parking spaces and altered other accessible parking spaces to bring them into compliance with the applicable Federal accessibility standards.
- **Keesler Air Force Base (Biloxi, Mississippi):** The Department of the Air Force took voluntary corrective action to install automatic door openers at the customer entrance of the Exchange Express (Building 1510) at the Base.
- **U.S. Naval Support Activity (Naples, Italy):** The Department of the Navy took voluntary corrective action to install accessible parking spaces in different parking lots at the facility.
- **VA Medical Center West Palm Beach (Riviera Beach, Florida):** The Department of Veterans Affairs took corrective action to repair the threshold of the main entrance door to this leased office space.



Parks and Historic Sites

- **Herbert Hoover Presidential Library and Museum (West Branch, Iowa):** The National Archives and Records Administration took voluntary corrective action to install automatic

door openers on one of the customer entrance doors as well as the men's and women's toilet room doors.

- **Campgrounds at or near Clearwater Lake (Piedmont, Missouri):** The U.S. Army Corps of Engineers installed a required van accessible parking space at campsite A6 in Piedmont Park and took corrective action to provide access to the electrical pedestals at campsites 36 and 37 in Webb Creek Park.



Internal Revenue Service

- **Internal Revenue Service (Frederick, Maryland):** The General Service Administration and the Internal Revenue Service took corrective action to bring the accessible parking spaces into compliance and made repairs to the ramp leading from the parking spaces to the accessible customer entrance.
- **Internal Revenue Service (Tulsa, Oklahoma):** The General Services Administration and Internal Revenue Service took corrective action to bring the ramp connecting the lower-level parking lot to the accessible customer entrance into compliance.



Other Facilities

- **Federal Correctional Institution (Tallahassee, Florida):** The Bureau of Prisons of the Department of Justice replaced a non-functioning platform lift used by visitors and employees.
- **Drug Enforcement Administration (Tucson, Arizona):** The Drug Enforcement Administration installed required accessible parking spaces in different parking lots at the facility.
- **Federal Communications Commission (Columbia, Maryland):** At its Office of Engineering and Technology Laboratory, the Federal Communications Commission took corrective action to make one of its entrances accessible.
- **General Services Administration (Kansas City, Missouri):** The General Services Administration took corrective action by installing accessible men's and women's single-user toilet rooms as alternatives to inaccessible toilet rooms on each floor of its leased space in the building.
- **Federal Aviation Administration (Washington, DC):** The Federal Aviation Administration completed corrective action to remediate barriers in certain toilet rooms and staff kitchens, and with respect to certain doors whose placement rendered certain routes inaccessible, opted to remove the doors entirely, resulting in greater accessibility.

Access Board Resolves 48 Architectural Barriers Act Cases Through Corrective Action in FY 2019

- **U.S. Post Office (Sparks Glencoe, Maryland):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) the force needed to manually open the doors.
- **U.S. Post Office (Stuart, Florida):** The Postal Service installed a required van accessible customer parking space and ensured that the route leading to the accessible entrance complied with the standards.
- **U.S. Post Office (Brooksville, Florida):** The Postal Service installed a required van accessible customer parking space.
- **U.S. Post Office (Catonsville, Maryland):** The Postal Service installed a required van accessible customer parking space.
- **U.S. Post Office (Portland, Oregon):** The Postal Service took corrective action to adjust, repair, or replace the door closer on a customer entrance door to lessen (and bring into compliance) the force needed to manually open the door.
- **U.S. Post Office (Kenwood, California):** The Postal Service took corrective action to replace a broken handle on the customer entrance door and correct an issue with the swing of the door.
- **U.S. Post Office (Springboro, Ohio):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) the force needed to manually open the doors.
- **U.S. Post Office (Longview, Texas):** The Postal Service installed two curb ramps and made alterations to the accessible parking spaces to bring them into compliance.
- **U.S. Post Office (Naperville, Illinois):** The Postal Service resurfaced and restriped the customer and employee parking lots and installed the minimum required number of accessible parking spaces (with conforming signage and access aisles).
- **U.S. Post Office (Council Grove, Kansas):** The Postal Service installed signage indicating the location of the accessible entrance and ramp leading to it.
- **U.S. Post Office (Old Saybrook, Connecticut):** The Postal Service installed signage to prevent vehicles from parking in and blocking an accessible route leading to the facility

entrance.

- **U.S. Postal Service Processing and Distribution Center (Dulles, Virginia):** The Postal Service took voluntary corrective action to move construction equipment that was impeding access to accessible employee parking spaces.
- **U.S. Post Office (Ketchikan, Alaska):** The Postal Service took corrective action to replace the existing double-leaf exterior entrance doors with an accessible single-leaf door, remove the change in level at the threshold of the exterior entrance door, and replace the existing automatic door openers for both the interior and exterior entrance doors.
- **U.S. Post Office (Forest City, North Carolina):** The Postal Service took corrective action to move the existing accessible parking space to a location adjacent to the entrance, and to install an associated curb ramp.
- **U.S. Post Office (Topeka, Kansas):** The Postal Service took corrective action to repair the existing automatic doors at the customer entrance.
- **U.S. Post Office (Ephrata, Washington):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) the force needed to manually open the doors.
- **U.S. Post Office (Jamestown, North Dakota):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) the force needed to manually open the doors.
- **U.S. Post Office (Federal Way, Washington):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) the force needed to manually open the doors.
- **U.S. Post Office (Racine, Wisconsin):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) the force needed to manually open the doors.

- **U.S. Post Office (Kingman, Arizona):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) the force needed to manually open the doors.
- **U.S. Post Office (Florence, Colorado):** The Postal Service took corrective action to install directional signage indicating the location of the accessible entrance.
- **U.S. Post Office (Gulfport, Mississippi):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) the force needed to manually open the doors.

- **U.S. Post Office (Imperial Beach, California):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) the force needed to manually open the doors.
- **U.S. Post Office (Covington, Kentucky):** The Postal Service took corrective action to repair the automatic door opener on the customer entrance door.
- **U.S. Post Office (Dongola, Illinois):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) the force needed to manually open the doors.
- **U.S. Post Office (Lebanon, Indiana):** The Postal Service took corrective action to adjust, repair, or replace the door closers on the customer entrance doors to lessen (and bring into compliance) the force needed to manually open the doors.
- **U.S. Post Office (Horsepen, Virginia):** The Postal Service took corrective action to install a ramp to the customer entrance and a van accessible parking space in the facility's parking lot.
- **U.S. Post Office (Lyons, Georgia):** The Postal Service took corrective action to install an accessible rear entrance ramp, directional signage, and a van accessible parking space.
- **U.S. Post Office (Lincoln, Illinois):** The Postal Service installed improved directional signage.
- **U.S. Post Office (Elgin, Texas):** The Postal Service took corrective action to install an accessible rear entrance ramp, along with directional signage.

Military and Veterans Affairs Facilities

- **Edwards Air Force Base (Edwards, California):** The Department of the Air Force took corrective action to remove a barrier in the accessible route from a building's entrance to its adjacent parking lot.
- **William Beaumont Army Medical Center (El Paso, Texas):** The Department of the Army took corrective action to install handrails on a ramp serving the interior of the building, to remedy several deficiencies in the exterior entrance ramp, and to repair damaged walkways leading to the building.
- **Joint Base Pearl Harbor-Hickam (Hawaii):** The Department of the Navy, in an effort to provide an alternative means for visitors to reach the facility's gymnasium (which already had an existing accessible entrance), voluntarily installed a chair lift at one set of stairs.
- **Greenville VA Health Care Center (Greenville, North Carolina):** The Department of Veterans Affairs installed 13 additional accessible parking spaces (for a total of 23, which is the requirement for patient and visitor parking at this outpatient medical facility) in the patient/visitor parking lot.



- **Greenville VA Health Care Center (Greenville, North Carolina):** The Department of Veterans Affairs installed 5 additional accessible parking spaces in the employee parking lot.

Parks and Historic Sites

- **Canyon Lake Dam (Canyon Lake, Texas):** The Access Board's investigation focused on the lack of accessible pedestrian gates leading to the road that runs atop the length of the dam – a road which is controlled by the Army Corps of Engineers but has served as a valuable recreational resource for decades. A grassroots campaign known as the Dam Community Alliance – in cooperation with other local organizations – raised funds for the purchase and installation of accessible gates and other safety features. - **Holly Creek Marina (Celina, Tennessee):** The U.S. Army Corps of Engineers, with the close cooperation of the concessionaire operating this marina on Dale Hollow Lake, corrected deficiencies in the main gangway connecting the main floating dock to the lakeshore, and remediated non-conforming changes of level at the connections between floating docks leading to the Marina's store and boat slips.



Social Security Administration Offices

- **Social Security Administration (Petersburg, Virginia):** The lessor, with the support of the General Services Administration (GSA) and Social Security Administration (SSA), took corrective action to install three new, compliant van accessible parking spaces (with associated signage, access aisles, and curb ramp) on the shortest accessible route to the building entrance.
- **Social Security Administration (Suffolk, Virginia):** The Social Security Administration took corrective action to install one new van-accessible parking space and one new regular accessible parking space (with associated signage, access aisle, and curb ramp) directly adjacent to the building entrance, and to move the button for the automatic entrance doors to a more accessible location.
- **Social Security Administration (Vicksburg, Mississippi):** The lessor, with the support of GSA and SSA, took corrective action to install compliant signage for the accessible parking spaces.
- **Social Security Administration (Vicksburg, Mississippi):** The lessor, with the support of GSA and SSA, took corrective action to resolve a second complaint concerning signage for the accessible parking spaces.



- **Social Security Administration (Athens, Georgia):** The General Services Administration (GSA) took corrective action to repair (and bring into compliance) an inaccessible walkway by replacing uneven brick pavers with a firm and stable concrete surface.

Other Facilities

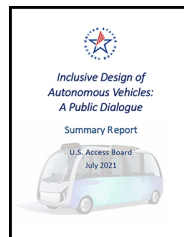
- **Joel W. Solomon Federal Building and United States Court House (Chattanooga, Tennessee):** The General Services Administration's Public Buildings Service, in consultation with GSA's Historic Buildings Program, undertook a major project to install a new compliant ramp at one of the main entrances to the historic building. In addition, GSA enlarged the entrance doorway and vestibule and installed a new automatic door opener. For more information on this case, click [here](#).
- **United States Bureau of Reclamation (Bend, Oregon):** The Department of the Interior took corrective action (including some voluntary corrective action) to improve the accessibility of two employee toilet rooms through alterations to door hardware and the placement of dispensers and signage.

Access Board Resolves 55 Architectural Barriers Act Cases Through Corrective Action in FY 2020

October 26, 2020

The Access Board was created in part to enforce the first federal law to address accessibility, the [Architectural Barriers Act of 1968 \(ABA\)](#). This law requires access to buildings or facilities that were designed, built, or altered with federal dollars or leased by federal agencies. The Board also maintains the guidelines upon which the ABA Standards are based.

With passage of other laws, including the landmark Americans with Disabilities Act (ADA), the Board's mission has expanded significantly. It is now responsible for developing and keeping up to date accessibility requirements for the wide array of facilities covered by the ADA, as well as for transportation vehicles and systems. It also issues standards for information and communication technology and for medical diagnostic equipment.

Despite these other duties, the Board continues the important work of enforcing the ABA. We do this through the investigation of complaints from the public. [Filing a complaint](#) with the Board is easy to do and can be done through an [online form](#). Complaints should include the name and address of the facility and a brief description of the access barriers or issues. Complaints can be filed anonymously.

The first step of an investigation is to determine whether the facility at issue is covered by the ABA. If so, the next step is to determine whether the facility meets the applicable accessibility standard. If the facility is not subject to the ABA or if it meets the appropriate accessibility standard, the Board will advise the complainant of its findings. Some facilities are not covered by the ABA but by other laws such as the ADA, which is enforced by other agencies and the courts.

If the facility does not meet the applicable standard, the Board will work with the responsible entities to develop a plan to bring the facility into compliance. Complaints are typically resolved amicably with the responsible agencies or departments. Cases remain open until all necessary

corrective action is completed. In FY 2020, the Board resolved 55 cases through corrective action – continuing an upward trend from 43 such cases in FY 2018 and 48 in FY 2019.

ABA Cases Resolved Through Corrective

(October 1, 2019 to September 30, 2020)

U.S. Postal Facilities – 37 Resolved Cases

- **U.S. Post Office (Cullman, Alabama):** The Postal Service took corrective action to adjust the manual opening force of two interior doors and two exterior doors.
- **U.S. Post Office (Ketchikan, Alaska):** The Postal Service took corrective action to repair the automatic doors at the customer entrance.
- **U.S. Post Office (Oro Valley, Arizona):** The Postal Service took corrective action to repair, adjust, or replace the door closers on the customer entrance doors to reduce the force needed to open them manually.
- **U.S. Post Office (Fullerton, California):** The Postal Service took corrective action to install a van accessible parking space and a compliant entrance ramp.
- **U.S. Postal Service Processing and Distribution Center (Redlands, California):** The Postal Service took corrective action to: install four accessible parking spaces and compliant curb ramps; install an accessible writing desk; lower two service counters to make them accessible; and adjust the manual opening force of four front entry doors and four vestibule doors.
- **U.S. Post Office (Trinidad, Colorado):** The Postal Service took voluntary corrective action to install a doorbell on the exterior of the facility so that patrons with disabilities can ring for staff assistance. The building was constructed prior to the enactment of the ABA and has not been altered since; for that reason, an accessible entrance is not required.
- **U.S. Post Office (Deltona, Florida):** The Postal Service took corrective action to adjust the manual opening force of two interior doors and two exterior doors.
- **U.S. Post Office (Fernandina Beach, Florida):** The Postal Service took corrective action to repair, adjust, or replace the door closers on the customer entrance doors to reduce the force needed to open them manually.
- **U.S. Post Office (Chicago, Illinois):** The Postal Service took corrective action at this facility, located in Chicago's Federal Center Plaza, to: mark the accessible entrance (which has an automatic door opener); repair, adjust, or replace the door closers on other manual customer entrance doors to reduce the force needed to open them; and install directional signage.
- **U.S. Post Office (Satanta, Kansas):** The Postal Service took corrective action to adjust the manual opening force of one interior door and one exterior door.



- **U.S. Post Office (Topeka, Kansas):** The Postal Service took corrective action to repair several automatic interior and exterior entrance doors at the facility entrance.
- **U.S. Post Office (Crittenden, Kentucky):** The Postal Service took corrective action to repair, adjust, or replace the door closers on the customer entrance doors to reduce the force needed to open them manually.
- **U.S. Post Office (Erlanger, Kentucky):** The Postal Service took corrective action to repair, adjust, or replace the door closers on the customer entrance doors to reduce the force needed to open them manually.
- **U.S. Post Office (New Orleans, Louisiana):** The Postal Service took corrective action to repair the automatic entrance door.
- **U.S. Post Office (Grandville, Michigan):** The Postal Service relocated a van accessible parking space to a proper location on the shortest accessible route to the facility entrance. The Postal Service took corrective action to adjust the manual opening force of one interior door and four exterior doors.
- **U.S. Post Office (Henderson, Minnesota):** The Postal Service took corrective action to repair the automatic door at the customer entrance.
- **U.S. Post Office (Mankato, Minnesota):** The Postal Service took corrective action to repair the automatic entrance door.
- **U.S. Post Office (Southaven, Mississippi):** The Postal Service took corrective action to install three accessible parking spaces, including one van accessible space, in the parking lot serving the facility.
- **U.S. Post Office (Starkville, Mississippi):** The Postal Service took corrective action to repair the manual door closers on three entrance doors.
- **U.S. Post Office (Platte City, Missouri):** The Postal Service took corrective action to repair an automatic exterior entrance door at the facility, and to replace the door closers on three interior doors to reduce the force needed to open them manually.
- **U.S. Post Office (North Platte, Nebraska):** In an effort to address pervasive, recurring mechanical problems with several automatic entrance doors at the facility, the Postal Service opted to remove the automatic door closers on each of the doors and replace them with standard manual doors that conform to the standards.
- **U.S. Post Office (Rio Rancho, New Mexico):** The Postal Service took corrective action to adjust the manual opening force of two interior doors and three exterior doors.
- **U.S. Post Office (New York, New York):** The Postal Service replaced existing manual customer entrance doors with automatic doors.
- **U.S. Post Office (Spencer, New York):** The Postal Service took corrective action to repair the automatic door at the customer entrance.
- **U.S. Post Office (Cincinnati, Ohio):** The Postal Service repaired the door closer on one of the customer entrance doors and installed a van accessible parking space, along with a compliant entrance ramp and compliant walkway connecting the parking space to the ramp.

- **U.S. Post Office (Medford, Oregon):** The Postal Service took corrective action to adjust the manual opening force and door closure speed for the exterior entrance door.
- **U.S. Post Office (Monroeville, Pennsylvania):** The Postal Service took corrective action to repair, adjust, or replace the door closers on the customer entrance doors to reduce the force needed to open them manually.
- **U.S. Post Office (Philadelphia, Pennsylvania):** The Postal Service took corrective action to repair, adjust, or replace the door closers on the customer entrance doors to reduce the force needed to open them manually.
- **U.S. Post Office (Reading, Pennsylvania):** The Postal Service took corrective action to adjust the manual opening force of two interior doors and two exterior doors.
- **U.S. Post Office (Charleston, South Carolina):** The Postal Service took corrective action to adjust the manual opening force of three interior doors and two exterior doors.
- **U.S. Post Office (Elgin, Texas):** The Postal Service installed a van accessible parking space at the facility.
- **U.S. Post Office (Killeen, Texas):** The Postal Service took corrective action to repair, adjust, or replace the door closers on the customer entrance doors to reduce the force needed to open them manually.
- **U.S. Post Office (Lindale, Texas):** The Postal Service took corrective action to remove displays and other obstructions that were impeding the accessible route from the facility entrance to the customer serving counter.
- **U.S. Post Office (Lockhart, Texas):** The Postal Service took corrective action to install an entrance ramp to the facility's addition, along with associated directional signage.
- **U.S. Post Office (Price, Texas):** The Postal Service took corrective action to install an accessible parking space.
- **U.S. Post Office (Ruther Glen, Virginia):** The Postal Service installed two new van accessible parking spaces and a new curb ramp on the accessible route connecting the parking spaces to the facility entrance.

Military and Veterans Affairs Facilities – 10 Resolved Cases

- **Joint Base Elmendorf-Richardson (Anchorage, Alaska):** The Base's command took corrective action to install an accessible parking space in a lot serving one of the buildings on base.
- **United States Naval Base Ventura County, Building 1443 (Port Hueneme, California):** The Department of the Navy took corrective action to modernize and repair the elevator providing access to the building's second floor.
- **Fleet Readiness Center Southeast, Building 168 (Jacksonville, Florida):** The Department of the Navy took corrective action to install a platform lift to provide access to the building's second floor.



- **Fleet Readiness Center Southeast, Building 168 (Jacksonville, Florida):** The Department of the Navy took corrective action to make the men's and women's toilet rooms accessible and to install a platform lift to provide access to the building's second floor.
- **Kilauea Military Camp (Volcano, Hawaii):** The Department of the Army took corrective action to install compliant toilet and shower rooms in four accessible cottages and two other guest buildings at this Morale, Welfare, and Recreation center.
- **Richard L. Roudebush VA Medical Center (Indianapolis, Indiana):** The Department of Veterans Affairs took corrective action to install an inclined platform lift to provide access to a suite of offices in one of the buildings at the Center.
- **Joint Base Andrews (Joint Base Andrews, Maryland):** The Department of the Air Force took corrective action to repair the elevator in one of the buildings on base.
- **Portsmouth Naval Shipyard (Portsmouth, New Hampshire):** The Department of the Navy took major corrective action to install, and/or bring into compliance with the standards, a cumulative total of 61 accessible parking spaces (including 11 van accessible spaces) in the various parking lots throughout the Shipyard.
- **Philadelphia Navy Yard (Philadelphia, Pennsylvania):** The Department of the Navy took corrective action to install four accessible parking spaces, including one van accessible space, in a parking lot serving one of the buildings at the facility.
- **Strike Fighter Wing Atlantic – Naval Air Station Oceana (Virginia Beach, Virginia):** The Department of the Navy took corrective action to install seven accessible parking spaces, including two van accessible spaces, in a parking lot serving one of the Wing's buildings at NAS Oceana.

Recreation Facilities – 5 Resolved Cases

- **Interpretive Center – Lewis and Clark National Historic Trail (Great Falls, Montana):** The U.S. Forest Service installed an assistive listening system in the auditorium/theater in this facility.
- **Three complaints concerning the Rockaway Boardwalk (Far Rockaway, New York):** The New York City Department of Parks and Recreation took corrective action to install access ramps at two different locations on the Rockaway Boardwalk, which had been rebuilt following Superstorm Sandy using funds from federal grants.
- **Washington Irving South Recreation Area – Keystone Lake (Sand Springs, Oklahoma):** The U.S. Army Corps of Engineers took corrective action to improve the accessibility of the ramp serving the gate house at the facility.



Other Facilities – 3 Resolved Cases

- **United States Customs and Immigration Service (Baltimore, Maryland):** The building's lessor, in consultation with the General Services Administration, took voluntary corrective

action to install a soap dispenser at the accessible lavatory in one of the building's toilet rooms.

- **Public sidewalk (Wilson, North Carolina):** The City of Wilson installed a curb ramp at a public sidewalk that had been constructed using funds from a Department of Transportation grant.
- **Central Puget Sound Regional Transit Authority (Seattle, Washington):** The Authority, commonly referred to as Sound Transit, installed an accessible parking space in an employee lot serving one of its buildings – a building which had been constructed using funds from a Department of Transportation grant.
