This letter is in final response to your Freedom of Information Act (FOIA) request dated February 10, 2025, which was referred to the Consumer Financial Protection Bureau (CFPB) by the Board of Governors of the Federal Reserve System on April 17, 2025. Your request sought:

I am requesting a list of the (FRB/CFPB) Inspector General INVESTIGATIONS closed during calendar years 2023 and 2024. The records should include information for each investigation, specifically the case number, the subject of the investigation, the category of the investigation, the open date, and the closing date.

A search of our Office of Inspector General for documents responsive to your request produced a total of one page, which is released in full, pursuant to Title 5 U.S.C. § 552. No deletions or exemptions have been claimed on these records.

Provisions of the FOIA allow us to recover part of the cost of complying with your request. In this instance, we have waived all fees related to the processing of your request.

You may appeal any of the responses or decisions set forth above. If you choose to file an appeal, you must do so within 90 calendar days from the date of this letter. Your appeal must be in writing, signed by you or your representative, and should contain the rationale for the appeal.
