This is in reference to your Freedom of Information Act (FOIA) request for DCSA FOIA Case Logs for each year from 2019 to the present and Defense Security Service (DSS) FOIA Case Logs from 2010 to 2019. You stated we may exclude the name and contact information of the requester and the subject of the request for First Party Requesters. We received your request in our office on March 6, 2025.

We maintain our logs pursuant to the General Records Schedule 4.2, item 040, for a period of five years after the date of last entry. Therefore, we only maintain logs from the beginning of fiscal year 2019 (October 1, 2019), which total 73 pages. The DCSA FOIA and Privacy Act office is comprised of three component offices, and logs dated October 1, 2019, to September 30, 2021, were managed separately by each component (pages 66 – 73). Data from our legacy systems is limited and a description of the requests was not maintained for the records on pages 70 – 72. On October 1, 2021, our program adopted a consolidated case management system (pages 1 – 65).

We reviewed the enclosed documents pursuant to the FOIA, title 5, United States Code §552. Review included consideration of the “foreseeable harm standard” (i.e., that information which might technically fall within an exemption should not be withheld from a FOIA requester unless the agency can identify a foreseeable harm or legal bar to disclosure). We withheld information that is exempt from disclosure pursuant to FOIA exemption (b)(6). This section exempts information that could reasonably be expected to constitute an unwarranted invasion of privacy. Regarding request for records pertaining to third parties, we released the names of deceased individuals.

You have the right to appeal this response by submitting a request to the FOIA Appellate Authority via e-mail at 11, or in writing to the Defense Counterintelligence and Security Agency, ATTN: FOIA Appellate Authority, P.O. Box 618, 1137 Branchton Rd, Boyers, PA 16018. If mailing your appeal, clearly mark the outside of the envelope and your written appeal letter: “Privacy/FOIA Appeal”. Appeals must be received by DCSA within ninety (90) calendar days from the date of this letter to be considered timely. Your written appeal letter should include the reasons why the requested information should be released and why this action may be in error. Include with your appeal letter a copy of your original request and this response letter. Please reference tracking number DCSA-B 25-06511.
