This letter responds to your Freedom of Information Act (FOIA) request received on 11 February 2025, by the Office of the Director of National Intelligence (ODNI), requesting “a list of the Office of the Inspector General of the Intelligence Community Investigations closed during calendar years 2023 and 2024.”

This request was processed under the FOIA, 5 U.S.C. § 552, as amended. ODNI located one document responsive to this request. During the review process, we considered the foreseeable harm standard and determined that certain information must be withheld pursuant to the following FOIA exemptions:

- (b)(3), which applies to information exempt from disclosure by statute. The relevant statute(s) is the National Security Act of 1947, as amended, Section 102A(m), as amended, 50 U.S.C. § 3024(m), which protects the names and identifying information of ODNI personnel.
- (b)(6), which applies to information that, if released, would constitute a clearly unwarranted invasion of personal privacy.

If you are not satisfied with this response, a number of options are available. The appeal correspondence should be clearly marked “Freedom of Information Act Appeal of Adverse Determination” and must be postmarked or electronically transmitted within 90 days of the date of this letter.
