RE: Final Letter - FOIA Request No. 2021-05-038

This is a final response to the Freedom of Information Act (FOIA) request you submitted on 05/20/2021, a copy of which is enclosed for your convenience. We received your submission on 05/20/2021 and assigned it FOIA number 2021-05-038. We ask that you use this number when referring to your request. You have requested access to the following records:

"A copy of the meeting agendas from meetings of the Advanced Counterfeit Deterrence Steering Committee during the time period January 1, 2010 to the present. The Treasury Department is responsible for maintaining the Committee Files of ACDSC since 1999."

Your request has been processed under the provisions of the FOIA, 5 U.S.C. § 552. We have considered the foreseeable harm standard when reviewing the responsive records and applying for FOIA exemptions.

The Office of Director (OD) conducted a reasonable search for records on June 21, 2021. In response to this search, OD located **61 pages** responsive to your request. After carefully considering these records, we are withholding **12 pages** in full and **49 pages** in part pursuant to exemption (b)(6), *See 5 U.S.C. § 552(b)(6) (2018)*.

Exemption (b)(5) - Deliberative Process Privilege

Exemption 5 protects inter-agency memorandums or letters which would not be available by law to party other than an agency in litigation with the agency. *See 5 U.S.C. § 552(b)(5) (2018)*. The deliberative process privilege incorporated within exemption 5 purpose is to prevent injury to the quality of agency decisions by (1) encouraging open, frank discussion on matters of policy between subordinates and superiors; (2) to protect against premature disclosure of proposed policies before they are adopted; and (3) to protect against public confusion that might result from disclosure of reasons and rationales that were not in fact, ultimately the grounds for an agency's action. *See, e.g., Russell v. Dep't of the Air Force, 682 F.2d 1045, 1048 (D.C. Cir. 1982)*.

In this matter we have withheld pre-decisional information of the U.S. Currency Program such as the titles of reports and executive summaries. This information contains sensitive unclassified information deemed Controlled Unclassified Information (CUI) and not to be disclosed outside the

U.S. Currency Program or used for any purpose other than its intended creation. [TREASURY DIRECTIVE 80-08 | U.S. Department of the Treasury.](#)

Exemption (b)(6)

Exemption 6 protects information about individuals in "personnel and medical files and similar files" when the disclosure of such information "would constitute a clearly unwarranted invasion of personal privacy." *See 5 U.S.C. § 552(b)(6) (2018)*. In order to determine whether exemption 6 protects against disclosure, courts require that agencies engage in the following four-step analysis: first, determine whether the information at issue is a personnel, medical, or "similar" file; second, determine whether there is a significant privacy interest in the requested information; third, evaluate the requester's asserted FOIA public interest in disclosure; and finally, if there is a significant privacy interest in non-disclosure and a FOIA public interest in disclosure, balance those competing interests to determine whether disclosure would constitute a clearly unwarranted invasion of personal privacy.

In this matter we have withheld conference line dial-in numbers and access codes. The information withheld contains private information of which disclosure could reasonably be expected to constitute an unwarranted invasion of privacy. There is no countervailing public interest in this information.

There are no fees assessed since allowable charges fell below \$25.

You have the right to file an administrative appeal of this decision within 90 days from the date of this letter. By filing an appeal, you preserve your rights under FOIA and give the agency a chance to review and reconsider your request and the agency's decision. Your appeal must be in writing, signed by you or your representative, and should contain the rationale for your appeal. Please also cite the FOIA reference number noted above. Your appeal must be postmarked within 90 days from the date of this letter.

If you would like to discuss this response before filing an administrative appeal to attempt to resolve your dispute without going through the appeals process, you may contact our FOIA Public Liaison for assistance via phone at (202) 874-2500. A FOIA Public Liaison is a supervisory official to whom FOIA requesters can raise questions or concerns about the agency's FOIA process. FOIA Public Liaisons can explain agency records, suggest agency offices that may have responsive records, provide an estimated date of completion, and discuss how to reformulate and/or reduce the scope of requests in order to minimize fees and expedite processing time.

If the FOIA Public Liaison is unable to satisfactorily resolve your question or concern, the Office of Government Information Services (OGIS) also mediates disputes between FOIA requesters and
