RE: Freedom of Information Act Request #25-F-00308: The requester is requesting: a list of the CPSC Office of Inspector General INVESTIGATIONS closed during calendar years 2023 and 2024. The records should include information for each investigation, specifically the case number, the subject of the investigation, the category of the investigation, the open date, and the closing date. The search timeframe is January 1, 2023, to December 31, 2024.

Thank you for your Freedom of Information Act (FOIA) request seeking records from the U.S. Consumer Product Safety Commission (CPSC). CPSC's Office of Inspector General (OIG) searched its records using the terms provided in your request. Enclosed is a copy of the responsive record, with certain excisions explained below. Portions of the enclosed record are being withheld pursuant to FOIA Exemption 6, 5 U.S.C. § (b)(6). CPSC considered the foreseeable harm standard when reviewing the record and applying FOIA exemptions.

Exemption 6. FOIA Exemption 6 permits withholding personnel and medical files and similar files, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy. Absent authorizations to disclose the records or personally identifying information from the persons identified in the records or their representatives, such information falls within the protection of this FOIA exemption to disclosure and is being withheld accordingly. OIG redacted the names of individuals under this exemption.

FOIA Administrative Procedures

Right to appeal. According to CPSC's regulations implementing the FOIA at 16 C.F.R. § 1015.7, a partial denial of access to records may be appealed. If you are not satisfied with the response to this request, you may administratively appeal in writing, addressed to FOIA APPEAL, Office of the General Counsel, ATTN: Division of Information Access, U.S. Consumer Product Safety Commission, 4330 East West Highway, Room 820, Bethesda, MD 20814-4408.

Before filing a formal appeal with the CPSC, you may contact me or CPSC's FOIA Public Liaisons, Amanda Civins (acivins@cpsc.gov) or Ayshe Rhoades (arhoades@cpsc.gov), via email or at 1-800-638-2772, for any further assistance, or to discuss any aspect of your request. Assistance may include guidance on possible reformulation of your request or an alternative time frame for processing the request.
