This letter is written in response to your request which was received by the Corporation for National and Community Service (CNCS) on December 12, 2011 for, "an electronic copy of the records provided to the Honorable Chairman Darrell Issa, whose office had in January 2011 asked your agency for various data concerning the administration of the Freedom of Information Act." You also asked to receive "a copy of any correspondence whatsoever sent to Chairman Issa's office on the subject of the January 2011 inquiry, and any correspondence sent during calendar year 2011 to Chairman Issa's office on the subject of FOIA."

Because we are a federal agency we are required to process your request in accordance with the Freedom of Information Act (FOIA). A review of our records shows that we have the following documents that are responsive to your request.
