# Subject: INFORMATION ON A THIRD PARTY - STANLEY, OWSLEY (AKA STANLEY, AUGUSTUS OWSLEY III) (DECEASED) – NADDIS REPORT

This letter responds to your Freedom of Information/Privacy Act (FOI/PA) request dated April 02, 2011, and your e-mail dated October 11, 2011, addressed to the Drug Enforcement Administration (DEA), Freedom of Information/Privacy Act Unit (SARF), seeking access to information regarding the above subject.

In the above e-mail, you narrowed the scope of your request for information pertaining to the above subject to encompass only the results of the search performed to date that identified 61 investigative files. You also requested a copy of the NADDIS report of that search (enclosed).

The processing of this portion of your request identified certain materials that will be released to you with this letter. Portions not released are being withheld pursuant to the Freedom of Information Act, 5 U.S.C. 552, and/or the Privacy Act, 5 U.S.C. 552a. Please refer to the list enclosed with this letter that identifies the authority for withholding the deleted material, which is indicated by a mark appearing in the block next to the exemption. An additional enclosure with this letter explains these exemptions in more detail.
