This is the electronic final response to your Freedom of Information Act (FOIA) request to the Department of Homeland Security (DHS), dated and received in this office on October 11, 2011, seeking a copy of a 58 page directory of DHS public affairs staff.

A search of the Office of Public Affairs for documents responsive to your request produced a total of 58 pages. As a result of discussion between agency personnel and a member of my staff, as a matter of administrative discretion, I am releasing the DHS Public Affairs Directorate. I have determined that 58 pages of the records are partially releasable pursuant to Title 5 U.S.C. § 552 (b)(6), FOIA Exemption 6.

Enclosed are 58 pages with certain information withheld as described below.

FOIA Exemption 6 exempts from disclosure personnel or medical files and similar files the release of which would cause a clearly unwarranted invasion of personal privacy. This requires a balancing of the public's right to disclosure against the individual's right privacy. The privacy interests of the individuals in the records you have requested outweigh any minimal public interest in disclosure of the information.

DHS maintains that the direct line phone numbers for individual staff members is information that does not directly reveal the operations or activities of the federal government, and as such, falls outside of the public ambit that the FOIA was enacted to serve. Further, this information related to individual employees does not shed light on how DHS performs its statutory duties. See *Department of Justice v. Reporters Committee for Freedom of the Press*, 489 U.S. 749, 775 (1989).

In addition, the DHS website lists a main phone number for the Office of Public Affairs, which is released in the responsive documentation. This phone number can be used to reach any staff

member. The website also provides press room phone numbers for each component, as well as an after business hours phone number. <http://www.dhs.gov/ynews/>.

You have a right to appeal the above withholding determination. Should you wish to do so, you must send your appeal and a copy of this letter, within 60 days of the date of this letter, to: Associate General Counsel (General Law), U.S. Department of Homeland Security, Washington, D.C. 20528, following the procedures outlined in the DHS regulations at 6 C.F.R. § 5.9. Your envelope and letter should be marked "FOIA Appeal." Copies of the FOIA and DHS regulations are available at www.dhs.gov/foia.

The Office of Government Information Services (OGIS) also mediates disputes between FOIA requesters and Federal agencies as a non-exclusive alternative to litigation. If you are requesting access to your own records (which is considered a Privacy Act request), you should know that OGIS does not have the authority to handle requests made under the Privacy Act of 1974. If you wish to contact OGIS, you may email them at ogis@nara.gov or call 1-877-684-6448.

Provisions of the FOIA allow us to recover part of the cost of complying with your request. In this instance, because the cost is below the \$14 minimum, there is no charge. 6 CFR § 5.11(d)(4).
