Subject: AmeriCorps Office of Inspector General, Freedom of Information Act Request No. [2026-19], Response

This letter is in response to your December 24, 2025, Freedom of Information Act (FOIA) request submitted electronically to the FOIA Officer for AmeriCorps. You requested: 1. A copy of the final report, closing memo, or equivalent concluding document for each Inspector General investigation closed during CY2025, and 2) A copy of the list of investigations closed during CY2025.

The AmeriCorps FOIA Office referred your request to this office for processing on January 6, 2025, as the matter relates to records under AmeriCorps Office of Inspector General (AmeriCorps OIG) jurisdiction and control.

AmeriCorps OIG posts documents concluding and summarizing OIG investigations on the AmeriCorps OIG website for the public. You may find those documents for calendar year 2025 at www.americorpsoig.gov.

As requested, please find the attached list of investigations closed during CY2025 responsive to your request. Certain information, such as personally identifiable information, including the identities of individuals and any other identifying information in the released record, has been withheld pursuant to Exemptions 6, 7(A) and 7(C) of the FOIA, 5 U.S.C. § 552(b)(6), (7)(a)(c). Exemption 6 authorizes the withholding of “personal and medical files and similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy.” Exemption 7(A) authorizes the withholding of “records or information compiled for law enforcement purposes but only to the extent that production of such law enforcement records or information... could reasonably be expected to interfere with enforcement proceedings.” At present, the release of certain information could cause such interference. Exemption 7(C) authorizes the withholding of “records or information compiled for law enforcement



purposes... to the extent that production of such law enforcement records or information... could reasonably be expected to constitute an unwarranted invasion of personal privacy.”

If you are dissatisfied with my action on this request, you may appeal by writing to Stephen Ravas, OIG FOIA Appeals Officer, AmeriCorps Office of Inspector General, 250 E Street SW, Suite 4100, Washington, DC 20525, or at FOIAAppeals@AmeriCorpsOIG.gov, within 90 days of your receipt of this letter. In the event you are dissatisfied with the results of any such appeal, judicial review is available to you in the United States District Court for the judicial district in which you reside, or in the District of Columbia, which is where the records you seek are located.

As an alternative to judicial review, the Office of Government Information Services (OGIS) offers mediation services to resolve disputes between FOIA requesters and Federal agencies as a non-exclusive alternative to litigation. Using OGIS does not affect your right to pursue litigation.
