This is an interim response to your Freedom of Information Act (FOIA) request for a listing of Office of Inspector General investigations closed during calendar years 2021 and 2022. We received your request on December 20, 2022 and assigned it case number DODOIG-2023-000288.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. 552(c) (2006 & Supp. IV 2010). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

The Defense Criminal Investigative Service (DCIS), Office of Professional Responsibility (OPR), and Administrative Investigations (AI) Components conducted a search. The DCIS and AI components located records responsive to your request. However, OPR does not keep a list of cases by closure date and it is not possible to generate such a list by electronic search.

Upon review, we determined the attached pages are appropriate for release in part pursuant to FOIA (5 U.S.C. § 552) exemptions (b)(6), when the disclosure of such information would constitute a clearly unwarranted invasion of personal privacy and (b)(7)(C), which protects personal information in law enforcement records.

Please be advised that the remaining pages responsive to your request are pending review with other agencies. Upon receipt of input from the other agencies, our Office will provide these pages to you as a final response to your request.

Our review included consideration of the foreseeable harm standard, as stated in DoDM 5400.07. Under this standard, the content of a particular record should be reviewed and a determination made as to whether the DoD Component reasonably foresees that disclosing it, given its age, content, and character, would harm an interest protected by an applicable exemption.
